However, unbeknown to the Commission, Sami Shabaan had died on January 29, 1991, two and one half months <u>before</u> the certificate was issued.

On June 27, 1991, Samia Shabaan, the surviving spouse of Sami Shabaan filed an application for charter party authority listing her intention to do business as E 2 Way Out Shuttle Service. In that application, under "Previously Issued Authority", she listed the TCP 6995-P authority as "issued to Sami Shabaan applicant's deceased husband." On August 21, 1991, pursuant to PU Code § 5384(b), a Charter Party Carrier Permit No. TCP 7358-P was granted to Samia Shabaan. What then is to be done? Samia Shabaan has been and is fouroperating this passenger stage service in the belief that she and the inherited the authority as she did the physical assets involved in the operation. If given authorization to do so, she states that again she will carry on the operation in the same manner and under the second same tariffs and timetables as were approved to be authorized to sold her husband in what has turned out to be an erroneous grantain and the D.91-04-016. The operation would continue to be conducted with these same vehicle fleet as at present, a vehicle fleet cleared by the form California Highway Patrol and properly insured. Samia Shabaan Composition presents the same financial condition, represented by the August 6, the 1991 balance sheet, as was found acceptable by the Commission in a part granting her Charter Party Carrier Permit No. TCP 7358-P on August 21, 1991. Granting the authority to and in the name of states Samia Shabaan will not in any way affect the existing service to the service to t the public. The matter is noncontroversial and will not adversely affect the public interest in any way. There would be no changes and the second state of th in rates.

Granting or withholding a certificate of public to be added convenience and necessity is an exercise of the State's power to be determine whether the rights and interests of the general public to be will be advanced by provision of the proposed service. The second discretion in acting upon an application for Commission's power and discretion in acting upon an application for a a certificate is very broad. (California Motor Transportation Company v. Railroad Commission (1947) 30 C 2d 184.) In the present matter, given the fact that the same evidence of need for the service, financial ability to provide it, ability to provide the service, etc., would have applied to the wife as it did to Sami Shabaan, had the Commission been informed of the husband's death and had Samia asked to substitute herself as the applicant, the certificate to operate issued invalidly on April 10, 1991 to her deceased husband undoubtedly would have been granted to her.

But we cannot do now what should have been done then. A "nunc pro tunc order" may be used to make the record reflect the transaction which actually occurred, and which is not reflected by the record because of inadvertence or mistake, but cannot be extended to make the record show what ought to have been done or to correct omissions or errors of the Commission.

Accordingly, since public convenience and necessity have been demonstrated, and Samia Shabaan has demonstrated that she has the ability, equipment, experience, and financial resources to continue to perform the service, a certificate should be granted to her.

Notice of filing of this application having appeared in the Commission's Daily Calendar of September 27, 1991, and there having been no protest, there is no need for a public hearing. <u>Pindings of Pact</u>

1. Sami Shabaan died, unbeknown to the Commission, on January 29, 1991, while A.90-11-034 was being processed.

2. D.91-04-016 was issued on April 10, 1991 to the deceased applicant whose surviving spouse Samia Shabaan accepted the certificate, obtained insurance and California Highway Patrol clearance, and has operated the service to date in the belief she had inherited the certificate as community property as she had inherited the assets used in the service.

3. Samia Shabaan has the ability, equipment, and financial resources to perform the passenger stage service she has been performing and now seeks to continue in her own right to perform.

4. No protests to the application have been filed.

5. It can be seen with certainty that the service will have no significant adverse effect on the environment. 6. A public need for the service has been demonstrated, and the is being met. Accordingly, the order which follows should be made effective immediately.

1. The authority intended to be granted to Sami Shabaan by D.91-04-016 issued April 10, 1991 in A.90-11-034 was rendered null and void by the death of Shabaan before the decision was signed by the Commission.

2. There is no certificate authority to operate a passenger stage service existing based on D.91-04-016 which can be transferred to Samia Shabaan as sought by the present application.

3. The doctrine of "nunceprontune" is not applicable to the set facts of this application.

4. Public convenience and necessity nonetheless have been demonstrated, and a certificate should be granted to Samia Shabaan to continue the passenger stage service she has been operating in the mistaken belief the service was authorized by the Commission.

SECTION I. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS, AND SPECIFICATIONS.

Samia Shabaan, an individual, by the certificate of public convenience and necessity granted by the decision noted in the margin, is authorized to transport passengers and their baggage on an "on-call" and scheduled basis, between the points described in Section II, and Oakland International Airport (OAK), over and along the routes described in Section III, subject, however, to the authority of this Commission to change or modify the routes at any time and subject to the following provisions:

- a. When route descriptions are given in one direction, they apply to operation in either direction unless otherwise indicated.
- b. The term "on-call", as used, refers to service which is authorized to be rendered dependent on the demands of passengers. The tariffs and timetables shall show the conditions under which each authorized on-call service will be rendered.
- c. No passengers shall be transported except those having a point of origin or destination at OAK.
- d. This certificate does not authorize the holder to conduct any operation on the property of or into any airport unless such operation is authorized by the airport authority involved.
