O P I N I O N

Petitioner C. L. Pharris Sand & Gravel, Inc. now produces, markets, and distributes sand and gravel from a facility located on Juniper Flats Road in Homeland, California. The plant's market area includes all of Los Angeles, Orange, Riverside, and San Bernardino Counties. Because this plant is not within any MRT 17-A production area, zone rates are not available for shipments from this location.

Petitioner seeks the establishment of a new production area including its facility and the creation of new zone rates for all points in the listed counties, with an appropriate amendment to the traverse map.

Notice was published in the Commission's Daily Transportation Calendar; no protests have been received.

Transportation Division has recommended that the petition be granted in the absence of protest.

Findings of Fact

1. Notice of the filing of the application appeared in the Daily Transportation Calendar. No protests have been filed. A hearing is not necessary.

2. The rates proposed by the petition will be just, reasonable, and nondiscriminatory.

3. Since this order grants rate relief, it should be effective today.

Conclusions of Law

1. MRT 17-A should be amended to extend zone rates from the proposed production area to all zones in Los Angeles, Orange, Riverside, and San Bernardino Counties.

2. Southern California Production Area and Delivery Zone Directory 1 should be amended to accommodate petitioner's facility at Juniper Flats Road, Homeland, California.

ORDER

IT IS ORDERED that:

1. Minimum Rate Tariff (MRT) 17-A, Appendix C to Decision 80578, as amended, is further amended by incorporating pages 6-Z, 6-Z-1, and 6-Z-2, attached, to become effective 39 days after today.

2. The Executive Director shall serve a copy of this decision on all subscribers to MRT 17-A.

3. This order grants the petition in full.


