OPINION MODIFYING DECISION 92-02-059

Background

Applicant Gregory J. Phelps, doing business as Mountain Express, was granted authority to operate scheduled airport transportation service between Placerville and Cameron Park in El Dorado County and the Sacramento Metropolitan Airport, five days a week, Thursday through Monday, pursuant to Decision (D.) 92-02-059. Modification of D.92-02-059

On February 28, 1992, applicant filed a petition for modification of D.92-02-059 (petition) to authorize service seven days a week instead of five days a week as originally requested and granted. The petition also requests schedule changes to better reflect airport schedules and local traffic conditions. The revised schedule is shown in Exhibit A attached to the petition.

Notice of filing of the petition appeared in the Commission's Daily Transportation Calendar on March 16, 1992.

There are no protests to the petition; therefore, a hearing is not necessary.

The petition is reasonable and will be adopted. Both the increase in service from five to seven days a week, and the schedule changes to better accommodate the airport and local traffic, will improve service to the public.

Findings of Fact

1. Applicant requests that D.92-02-059 be modified to authorize service seven days a week and to accommodate a revised schedule.

1. Gregory J. Phelps' (applicant) petition for modification of Decision (D.)92-02-059 (petition) is adopted: applicant is authorized to operate scheduled airport transportation service seven days a week using the schedule shown in Exhibit A attached to the petition.

2. Except to the extent modified by this decision, D.92-02-059 remains in full force and effect.
