In the Matter of Samia A. Shabaan, dba EZ Way Out Shuttle Service, to reflect amendments requesting authority to operate as a passenger stage corporation between points in Contra Costa, Alameda, San Joaquin, San Mateo, and San Francisco counties, including San Francisco International Airport.

Application 91-09-042 (Filed September 23, 1991; amended October 4, 1991 and February 7, 1992)

#### INTERIM OPINION

#### Statement of Facts

By Decision (D.) 91-12-007 issued December 4, 1991 in Application (A.) 91-09-042, the Commission nullified an earlier ineffective certificate,<sup>1</sup> and granted a certificate of public convenience and necessity to operate as a passenger stage corporation to Samia A. Shabaan (applicant), doing business as EZ Way Out Shuttle Service. The authority granted was for operations between Oakland International Airport and West Bay points, and the City of Santa Rosa.

While the decision on A.91-09-042 was pending, Shabaan on October 4, 1991 filed what was intended to be an amendment, seeking expansion of the earlier application to embrace additional authority to include scheduled operations between points in San Francisco, San Mateo, and San Joaquin counties. Because the caption failed to conform with various aspects contained in the body of the amendment, the amendment was held rather than delay the

authority being granted by pending D.91-12-007.<sup>2</sup> Meanwhile, our Transportation Division staff worked with the applicant's representatives to conform the amendment. These efforts led to the filing of an amendment to the amendment on February 7, 1992.

The February 7, 1992 amendment asks authority to extend existing authorized service to provide:

- On-call service between various San Francisco zip code locations and the Oakland International Airport;
- On-call services between San Mateo County cities and the Oakland International Airport, or the San Francisco International Airport;
- On-call services between Stockton, Manteca, Tracy, and the Oakland International Airport or the San Francisco International Airport; and
- 4. Scheduled service (a) every two hours between Oakland International Airport and the Sheraton Palace, Grand Hyatt, and Hyatt Wharf Hotels on New Montgomery, Stockton and Northpoint respectively, in San Francisco, and (b) every 1/2 hour between the San Francisco International Airport and the Marriott, Pan Pacific, Sir Francis Drake, and Fairmont hotels on 4th Street, Post, Powell, and Mason respectively, in San Francisco.

Shabaan's initial application listed two eight passenger and two 12 passenger vans in service, and a net worth of \$12,000. The applicant has also introduced letters from the Oakland Airport Manager and the Special Assistant to the Executive Director for

Surface Transportation, Port of Oakland, supporting the application and stating the "overwhelming requests from hotels, corporations, and general public" for increased scheduled transbay service. The letters ask for expedited ex parte approval.

The instant caption, amended to conform the authorities sought with the October 4, 1991 and February 7, 1992 amendments, and to provide notice, appeared on the Commission's Daily Calendar of April 6, 1992, and on the Commission's Transportation Calendar of April 7, 1992. On May 4, 1992, a protest and request for oral hearing was filed by SFO Airporter, Inc. The protest was to the requested grant of scheduled service between San Francisco International Airport and designated hotels in San Francisco. <u>Discussion</u>

The applicant's prior service record indicates that its presently authorized service has been well received by the public and Port of Oakland authorities. The fares and charges proposed appear to be reasonable for the proposed transbay service. The Port of Oakland letters both reflect a need for increased transbay services. Accordingly, since public convenience and necessity have been demonstrated for such expanded transbay service, and the applicant has demonstrated she has the ability, equipment, experience, and financial resources to enter upon the expanded transbay service proposed, the requested extended transbay authority should be granted. In view of the delays experienced, the requested transbay extended authority should be granted effective immediately.

However, applicant's request to be granted additional authority to provide scheduled service between the San Francisco International Airport and designated hotels in San Francisco has been protested, and a determination on this portion of the captioned application will be set for hearing.

# Pindings of Pact

1. Applicant has the ability, equipment, experience, and financial resources to perform the proposed expanded transbay service.

2. Public convenience and necessity require the proposed transbay service.

3. It can be seen with reasonable certainty that there is no possibility that the activities in guestion may have a significant adverse effect on the environment.

4. As these amendments involve only the expansion of an existing service, the order should be effective on date of signing. <u>Conclusion of Law</u>

Public convenience and necessity have been demonstrated with regard to expanded transbay service and an expanded certificate of public convenience and necessity should be granted.

Only the amount paid to the State for operative rights may be used in rate fixing. The State may grant any number of rights and may cancel or modify the monopoly feature of these rights at any time.

# INTERIM ORDER

# IT IS ORDERED that:

1. The certificate of public convenience and necessity granted to Samia A. Shabaan (applicant), authorizing her to operate as a passenger stage corporation, as defined in Public Utilities (PU) Code § 226, between the points and over the routes set forth in Appendix PSC-7358, to transport persons and baggage, is amended to add First Revised Pages 1, 2, 3, 4, and Original Pages, which cancel Original Pages 1, 2, 3, and 4.

- 2. Applicant shall:
  - a. File a written acceptance of this certificate within 30 days after this order is effective.

- b. Establish the authorized service and file tariffs and timetables within 120 days after this order is effective.
- c. State in her tariffs and timetables when service will start; allow at least 10 days' notice to the Commission; and make timetables and tariffs effective 10 or more days after this order is effective.
- d. Comply with General Order Series 101, 104, and 158, and the California Highway Patrol safety rules.
- e. Naintain accounting records in conformity with the Uniform System of Accounts.
- f. Remit to the Commission the Transportation Reimbursement Fee the required by PU Code § 403 when notified by mail to do so.

3. Before beginning service to the San Francisco International Airport, applicant shall notify the airport's governing body. Applicant shall not operate into or on San Francisco International Airport property unless such operations are also authorized by the airport's governing body.

4. Applicant is authorized to begin the expanded operations set forth herein on the date that the Executive Director mails a notice to applicant that her evidence of insurance is on file with the Commission and that the California Highway Patrol has approved the use of applicant's vehicles for service.

5. Applicant shall comply with PU Code § 460.7 and 1043, relating to the Workers' Compensation laws of this state.

#### \*SECTION I. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS, AND SPECIFICATIONS.

Samia A. Shabaan, an individual, by the certificate of public convenience and necessity granted by the decision noted in the margin, is authorized to transport passengers and their baggage on an "on-call" and scheduled basis, between the points described in Section II, over and along the routes described in Section III, subject, however, to the authority of this Commission to change or modify the routes at any time and subject to the following provisions:

- a. When route descriptions are given in one direction, they apply to operation in either direction unless otherwise indicated.
- b. The term "on-call", as used, refers to service which is authorized to be rendered dependent on the demands of passengers. The tariffs and timetables shall show the conditions under which each authorized on-call service will be rendered.
- c. No passengers shall be transported, including between San Francisco (SFO) and Oakland (OAK) International Airports, except those having a point of origin or destination at either (SFO) or (OAK).
- d. This certificate does not authorize the holder to conduct any operation on the property of or into any airport unless such operation is authorized by the airport authority involved.
