These certificates should have been combined into PSC-1411, and prior certificates PSC-1333, PSC-1366 should be revoked.

- 2. PSC-1366 Certificate of Public Convenience and Necessity is revoked.
- 3. Routes and service areas authorized in PSC-1333 and PSC-1366 are combined into a new Certificate of Public Convenience and Necessity for PSC-1411.

SECTION I. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS, AND SPECIFICATIONS.

PCSTC, INC., by the certificate of public convenience and necessity granted by the decision noted in the margin, is authorized to transport passengers between certain areas in the City of Anaheim on the one hand and points in the cities of Buena Park, Costa Mesa and Laguna Hills on the other hand, over and along the routes described, subject, however, to the authority of this Commission to change or modify these routes at any time and subject to the following provisions:

- a. Motor vehicles may be turned at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersections, in accordance with local traffic regulations.
- When route descriptions are given in one direction, they apply to operation in either direction unless otherwise indicated.
- c. On Route A no passengers shall be transported except those having point of origin or destination at Movieland Wax Museum or Knott's Berry Farm.
- d. On Route C service shall be rendered on a regularly scheduled basis.
- e. On Route C no passengers shall be transported except those having point of origin or destination at South Coast Plaza shopping center.

SECTION 2. SERVICE AREAS

Service Areas

(Route A) The Disneyland Service Area is that portion of the City of Anaheim bounded on the north by Vermont Avenue, on the east by State College Boulevard, on the south by the Anaheim city limits, and on the west by Walnut Street.

(Route B) The Anaheim Service Territory includes all hotels and motels within the following boundaries: Lincoln Avenue, on the north; State College Blvd., on the east; Chapman Avenue, on the south; and Euclid Avenue, on the west.

(Route 2A) - Conestoga Inn - Sheraton - Anaheim - Space Age Lodge west on Ball Road, then south on West Street, then west on Katella Avenue to the Best Western Fabulous Space Age Lodge (service point), 1176 Katella Avenue, in Anaheim, then east on Katella Avenue, then north on Harbor Boulevard, then northwest on the Santa Ana Freeway (Interstate 5), then west on the Riverside Freeway (State Highway 91), then South on Beach Boulevard to Movieland Wax Museum (service point), 7711 Beach Street, in Buena Park, then south on Beach Boulevard to Knott's Berry Parm (service point), 8039 Beach Boulevard, in Buena Park.
