ORDER OF DISMISSAL

The Transportation Division (Staff) has visited Joanne H. Blizzard (Applicant) at her office on two separate occasions to discuss applicant's intent to amend application and the necessary information that should be included in it. The amendment would have provided a description of the proposed routes and points of service, and a statement of the proposed fares and timetables for these points of service. Applicant was placed on notice by staff letters dated July 26, 1991 and March 20, 1992 to amend the application.

The letter of March 20th stated that the staff will recommend to the Commission to dismiss the application if the amendment was not filed by April 15, 1992. Applicant has not responded in any manner.

Findings of Fact

1. This application is procedurally defective because it lacks a description of proposed routes and points of service, and a statement of the proposed fares and timetables.

2. Transportation Division staff has met with applicant on two separate occasions and has also twice advised her by letter that the application is defective and should be amended.

3. Applicant has failed to respond, and has not amended the application.

CONCLUSION OF LAW

This application should be dismissed due to applicant's failure to pursue it.

IT IS ORDERED that the application of Joanné M. Blizzard, dba Easy Ride Commute is dismissed effective today.


