ORDER CORRECTING ERROR IN DECISION 91-12-005

By a series of decisions,¹ Southern California Edison Company and San Diego Gas & Electric Company, jointly referred to as petitioners, have been authorized from time to time to realign their common boundary. By a petition for modification, filed on March 20, 1992, petitioners seek to replace two incorrect maps attached to D.91-12-005 at Pages 8 and 10 of Appendix A. We agree. The petition for modification should be granted.

Findings of Fact

1. D.91-12-005 needs to be corrected by replacing two incorrect maps at Pages 8 and 10 of Appendix A.
2. There is no opposition to the petition for modification.

ORDER

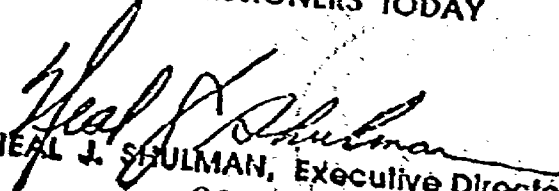

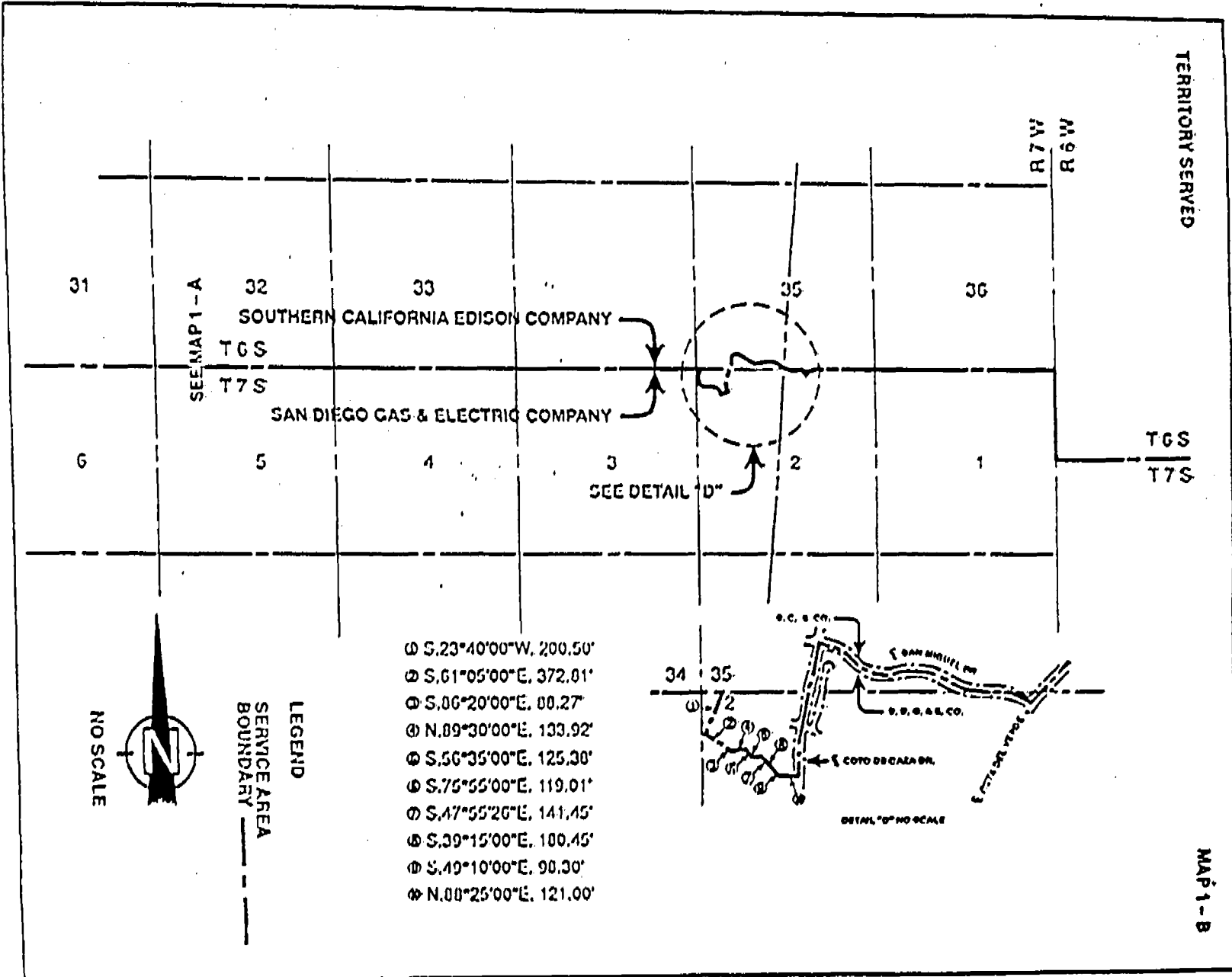

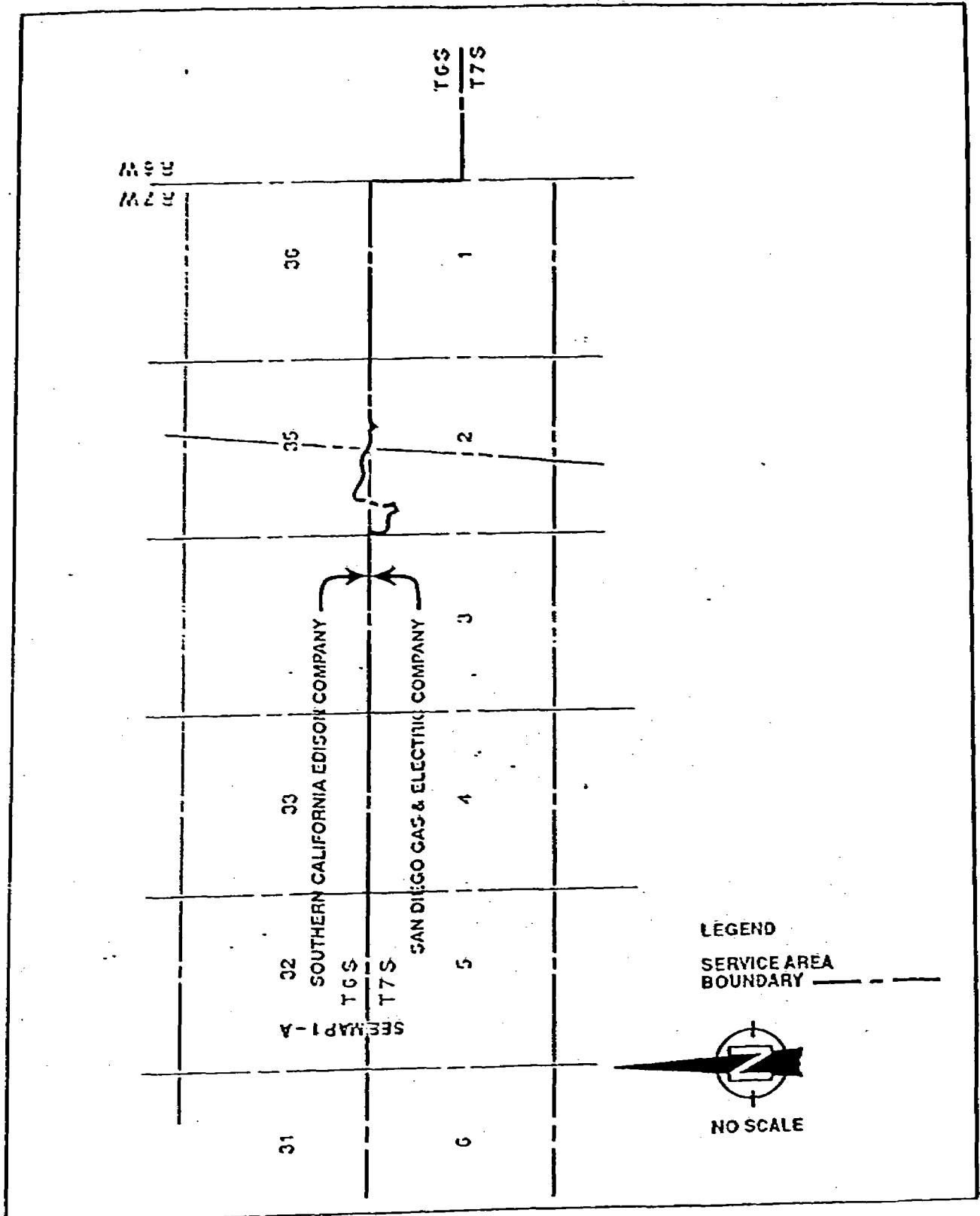
