**ORDER CORRECTING ERROR**

Decision 92-06-028 granted authority to Samia A. Shabaan to extend her passenger stage service areas, including a Route 4 between the city of San Francisco and the Oakland Airport (OAK).

Inadvertently, this Route 4 was described as service between the city of San Francisco and the San Francisco International Airport(SFO).

Oakland International Airport(OAK) should be in the description of Route 4.

IT IS ORDERED that Appendix PSC-7358 of D.92-06-028 is amended by replacing Original Page 5 with First Revised Page 5, as attached.

SECTION III. ROUTE DESCRIPTION.

ON-CALL SERVICE

Route 2 - OAK/Contra Costa and Alameda Counties

Commencing from OAK then to any point or place in Concord, Walnut Creek, Lafayette, Orinda, Berkeley, Everyville, Albany, Richmond, El Cerrito, San Ramon, Hayward, and Fremont.

Route 3 - OAK/Santa Rosa

Commencing from Oakland International Airport then to Santa Rosa.

\*Route 4 - OAK/San Francisco

Commencing from (OAK) then to the City of San Francisco as described in Section II.

Route 5 - SFO/ San Mateo County

Commencing from SFO, then to any point or place in San Mateo County as described in Section II.

Route 6 - OAK/ San Mateo County

Commencing from OAK, then to any point or place in San Mateo County as described in Section II.

Route 7 - OAK/ SFO/San Joaquin County

Commencing from OAK or SFO, then to any point or place in the cities of Stockton, Manteca, and Tracy. No person or baggage shall be transported between OAK and SFO.
