In the Matter of the Application of Gary R. Bowen and Ronald E. Ibold, doing business as EAST VALLEY LINES to transfer a portion of a Certificate of Public Convenience and Necessity to Ronald E. Ibold who is desolving (sic) his partnership with Gary R. Bowen who will continue to provide service as EAST VALLEY LINES, Ronald E. Ibold will continue to provide service as BLOSSOM VALLEY COMMUTE.

<u>O P I N I O N</u>

Gary R. Bowen and Ronald E. Ibold (applicants), doing business as East Valley Lines, seek authority to terminate their partnership and divide their passenger stage operating authority between them. Subject of this application is the certificate of public convenience and necessity (PSC-1047) granted in Decision (D.) 91083 dated November 30, 1979 in Application (A.) 59133.

The certificate authorizes transportation between ten points in San Jose and Sunnyvale and the United Air Lines Maintenance Base at San Francisco International Airport. If this application is granted, Ibold will serve five of the San Jose-Sunnyvale points and Bowen will serve five of them. In addition, Bowen would serve one new point for a total of six service points in the San Jose area.

As noted, applicants have been operating as a passenger stage corporation since 1979. Further, Ibold holds a separate, temporary certificate of public convenience and necessity to operate a similar service between San Jose and United (PSC-1161 issued under the Commission's expedited application procedure for new commuter bus routes, by D.92904 dated April 7, 1981 in A.60279). Applicants' financial statement shows Bowen's net worth at \$60,000 and Ibold's at \$140,000. Each will have operating equipment after the dissolution of their partnership.

The application was listed on the Commission's Daily Calendar and applicants served copies on interested parties. The Commission's Transportation Division staff has reviewed the application and recommends that in the absence of protest or request for public hearing, it be granted by ex parte order. No protest or request for hearing has been received. A public hearing is not necessary.

Findings of Fact

1. Each applicant has the experience, facilities, equipment, and financial ability to operate the subject passenger stage services.

2. It is in the public interest to ensure the continued operation authorized under the certificate. Applicants will continue to operate in a manner satisfying the public need for transportation. <u>Conclusion of Law</u>

The proposed dissolution of partnership is in the public interest and should be authorized. A public hearing is not necessary.

Only the amount paid to the State for operative rights may be used in rate fixing. The State may grant any number of rights and may cancel or modify the monopoly feature of these rights at any time.

ORDER

IT IS ORDERED that:

1. Within 90 days after the effective date of this order, Gary R. Bowen and Ronald E. Ibold may dissolve their partnership and transfer the operative rights specified in the application.

- 2. Each applicant shall:
 - a. File with the Transportation Division written acceptance of the certificate and a copy of the dissolution of partnership within 30 days after dissolution of partnership.
 - b. Amend or reissue tariffs and timetables, state in them when the service will start, make them effective 10 or more days after this order is effective, and allow at least 10 days' notice to the Commission.
 - c. Comply with General Orders Series 79, 98, 101, and 104, and the California Highway Patrol safety rules.
 - d. File an annual report of operations for the period from the first day of the current year to the date of transfer.
 - e. Maintain accounting records in conformity with the Uniform System of Accounts.

3. If the dissolution of partnership is completed, on the effective date of the tariffs, a certificate of public convenience and necessity is granted to Gary R. Bowen and Ronald E. Ibold, authorizing each of them to operate as a passenger stage corporation, as defined in FU Code Section 226, between the points and over the routes set forth in Appendixes A and B.

4. Upon the issuance of certificates as provided in the preceding ordering paragraph, the certificate of public convenience and necessity granted by D.91083 in A.59133 is hereby cancelled.
