## SUPPLEMENTAL ORDER AMENDING DECISION 93079

By Decision (D.) 93079 dated May 19, 1981 in Application (A.) 60286 the Commission granted JETOUR USA, Inc. (JETOUR) (PSC-1160) a temporary certificate of public convenience and necessity authorizing operations as a passenger stage corporation for the transportation of passengers on sightseeing tours between various points of interest throughout the State.

By an amendment filed August 5, 1981 JETOUR requests the inclusion of a Knott's Berry Farm and Movieland Wax Museum tour, which was inadvertently omitted from the original application.

All of the reasons justifying the grant of the temporary certificate also justify the amendment of the certificate by including the requested tour, which would commence at the Los Angeles hotel of passengers, thence over Highway 5 to Movieland Wax Museum, sightseeing at Movieland Wax Museum and Knott's Berry Farm, and return to the Los Angeles hotel.

On November 13, 1981 we issued D.93725 in A.59818 et al. reanalyzing whether sightseeing-tour service is passenger stage corporation service. That decision makes the issuance of a certificate to a carrier engaged 100% in round-trip sightseeing unnecessary. However, recognizing that decision will be subject to further review, we will, as a precaution, issue an amendment to JETOUR's temporary certificate, since public need for the service is established.

## Finding of Fact

Public convenience and necessity require that JETOUR's temporary certificate be amended to include the tour described above. Conclusions of Law

1. In D.93726 (November 13, 1981) in consolidated A.59818, 60174, 60181, 60221, and 60286, the Commission ordered:

"Applications 59818, 60174, 60181, 60221, and 60286 are granted to the extent that the temporary certificates previously issued continue in effect until further order of the Commission."

2. In order to avoid any question whether JETOUR's temporary certificate, as amended by the following order, is subject to the order quoted above, we should issue the temporary certificate <u>nunc</u> <u>pro tunc</u> as of August 5, 1981, the date the amendment to the application was filed.

3. As this is an ongoing tour requiring prompt authorization, this order should be made effective today.

IT IS ORDERED that:

 Appendix D of D.93079 is amended nunc pro tunc to August 5, 1981 by substituting First Revised Page 3, attached, for Original Page 3.

2. Within 60 days after the effective date of this order and on not less than 5 days' notice to the Commission and to the public, A.60286 ALJ/bw

SECTION III. TOUR DESCRIPTIONS - LOS ANGELES.

# Tour - Description

1 Disneyland Tour

Leave Los Angeles for Disneyland via the Santa Ana Freeway. Return to Los Angeles via the Santa Ana Freeway.

## 2 <u>Gourmet Night Tour</u>

Depart hotels for dinner at a Beverly Hills restaurant, to the Griffith Observatory. Return to hotels late evening.

3 <u>San Diego and Tijuana</u>

Depart Los Angeles via Route #5, driving along the coastline and arriving in San Diego, stopping at sites such as Point Loma, Harbor Island, Downtown, and continuing to the American/Mexican Border. Walk across the border and ride to the town of Tijuana. Return to Los Angeles via Route #5, arriving in the late evening.

#### \*4 Knott's Berry Farm and Movieland Wax Museum Tour

Commencing at the Los Angeles hotel of the passengers, then over Highway 5 to Movieland Wax Museum, sightseeing at Movieland Wax Museum and Knott's Berry Farm, and return to the Los Angeles hotel.
