O P I N I O N

Aime Joseph Hebert (Hebert), doing business as Aime Hebert and Sons Trucking and Excavating, seeks a dump truck carrier permit to operate in the Counties of Nevada, Placer, Yuba, Sacramento, Butte, and Plumas.

Hebert's application is supported by Robinson Timber, Grass Valley, and by Hansen Bros. Enterprises, Grass Valley. As of December 18, 1981 Hebert shows total assets of \$156,351 and a net worth of \$126,351. He estimates required working capital for 45 days of operation at \$2,238 compared to cash and/or current liquid assets of \$10,000. Hebert's estimate of profit and loss for 90 days of operation shows a net profit of \$5,248.

Hebert at present has no California operating authority. He has one end dump truck. Hebert certifies that he has resided in California for not less than 90 days preceding this filing.

Notice of filing of the application appeared in the Commission's Daily Calendar of January 4, 1982. Copies of the application were served on several associations of carriers with whom the proposed service is likely to compete. No protests to the application have been received.

Findings of Fact

1. Hebert is a fit and proper person to receive a permit as a dump truck carrier and possesses sufficient operating knowledge and financial ability to initiate and continue the proposed operation.

2. Hebert's equipment will not endanger the safety of highways nor impair the condition or maintenance of them either directly or indirectly.

3. Hebert's proposed operation will not unnecessarily burden the public highways, is necessary to serve the public, and will not impair the ability of presently permitted dump truck carriers to provide adequate service at the lowest possible reasonable rates.

4. Hebert has been a California resident for not less than 90 days preceding this filing.

5. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

6. The following order complies with the guidelines of the Commission's Energy Efficiency Plan.

7. A public hearing is not necessary.

Conclusion of Law

The application should be granted. The effective date of the following order should be the date of signature to be consistent with the issuance of permits to other classes of carriers.

O R D E R


