ORDER OF REVOCATION

Commission Decision (D.) 93240, dated June 16, 1981, granted a certificate of public convenience and necessity to F. & M. Mini-Bus Corporation to operate as a passenger stage corporation (PSC-1165) to transport home-to-work passengers between points in Redwood City, San Carlos, and Belmont and points in San Francisco.

Ordering Paragraph 2 of D.93240 required applicant to file a written acceptance of the certificate by July 16, 1981, file tariffs and timetables by October 2, 1981, and satisfy the insurance requirements of the Commission's General Order 101.

On June 22, 1981, the Commission staff sent applicant a letter reiterating the requirements of D.93240 and cautioned that failure to comply may result in a cancellation of the authority.

On December 30, 1981, the Commission staff sent applicant a letter reminding that the deadline to comply with the requirements of D.93240 had passed and that, if the Commission did not hear from applicant, the Commission staff would be forced to recommend that the certificate be revoked.

Applicant has not responded to the two letters and, in fact, has not sent any correspondence to the Commission since D.93240 was granted on June 16, 1981.

It appears and the Commission finds that these matters constitute good cause for the revocation of the certificate and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that the certificate should be revoked.

IT IS ORDERED that the certificate of public convenience and necessity granted to F. & M. Mini-Bus Corporation to operate as a passenger stage corporation, authorized by D.93240, is revoked.


