ORDER OF REVOCATION

Commission Decision (D.) 93698, dated November 3, 1981, granted a certificate of public convenience and necessity to Airport Express of Modesto, Inc., to operate as a passenger stage corporation, PSC-1185, as defined in Section 226 of the Public Utilities Code, transporting passengers between Modesto and San Francisco International Airport.

Ordering Paragraph 2 of D.93698 required applicant to comply with the insurance requirements of the Commission's General Order Series 101 and file tariffs and timetables by March 3, 1982.

In a letter dated November 6, 1981, the Transportation Division staff reminded the carrier of its obligations regarding compliance with the above requirements.

By a letter, dated March 15, 1982, the staff reminded the carrier that the required tariff and timetable were not filed and that it had not had a certificate of liability insurance on file. The letter specifically cautioned the carrier that unless it complied with all the filing requirements by March 26, 1982, the staff would recommend to the Commission that its passenger stage authority be revoked.

The carrier, by letter dated March 25, 1982, requested that the Commission withdraw the certificate granted by D.93698.

The Commission finds that these matters constitute good cause for the revocation of this certificate and that such revocation would not be adverse to the public interest. The Commission therefore concludes that the certificate should be revoked.

IT IS ORDERED that the certificate of public convenience and necessity (PSC-1185) to operate as a passenger stage corporation authorized by Decision 93698 is revoked upon the effective date of this order.


