<u>opinion</u>

Applicant Sonny O. Basso, doing business as Lake Arrowhead Transportation Co., seeks a certificate of public convenience and necessity to operate as a passenger stage corporation to transport passengers around Lake Arrowhead and its vicinity as described in Exhibits C, D, and E to the application. Applicant proposes to operate service on an hourly basis each day from 7 a.m. to 7 p.m. initially, using either a 17-passenger or a 15-passenger bus for the operation.

Notice of filing of the application appeared on the Commission's Daily Calendar dated February 25, 1982 and copies of the application were served upon Greyhound Lines, Inc., Trailways, Inc., Omnitrans, California Department of Transportation, Scutnern California Rapid Transit District, the San Bernardino County Board of Supervisors, Assemblyman William Leonard, the San Bernardino Associated Governments, and Mountain Area Transit Company. No protests were received.

Applicant states he currently owns a 15-passenger vehicle and has a 17-passenger "Mini Transit Bus" available for immediate delivery.

Applicant alleges that there are no other passenger carriers serving this area which has a summer population of 47,000 with an off-season population of 9,509 including many senior citizens and "transit dependents".

Applicant alleges that this service will provide transportation for medical visits and shopping, as well as recreational trips.

Applicant alleges that a demand for public transportation now exists as a result of population increase, redevelopment, "future projections", new hotel facilities, and additional retail establishments, and that this service will reduce traffic congestion during vacation and holiday months, conserve fuel, and thus add to the conservation of clean air.

Applicant further alleges that he has the financial ability to render this service. His most recent financial statement indicates current assets of \$1,614,500 and current liabilities of \$770,000. While the statement does not provide a complete portrayal of applicant's financial status for business purposes, it tends to support applicant's allegation.

Findings of Fact

- 1. Applicant has the ability, experience, and financial resources to perform the proposed service.
- 2. Applicant's proposed service contemplates the use of 15- and 17-passenger capacity buses for transporting residents and visitors around the perimeter of Lake Arrowhead and its vicinity.

3. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

Conclusion of Law

- 1. Public convenience and necessity require that the requested authority should be issued.
- 2. Only the amount paid to the State for operative rights may be used in rate fixing. The State may grant any number of rights and may cancel or modify the monopoly feature of these rights at any time.

ORDER

IT IS ORDERED that:

1. A certificate of public convenience and necessity is granted to Sonny O. Basso, doing business as Take Arrowhead Transportation Co., authorizing him to operate as a passenger stage corporation, as defined in PU Code Section 226, between the points and over the routes set forth in Appendix PSC-1217, to transport persons.

2. Applicant shall:

- a. File a written acceptance of this certificate within 30 days after this order is effective.
- b. Establish the authorized service and file tariffs and timetables within 120 days after this order is effective.
- c. State in his tariffs and timetables when service will start; allow at least 10 days' notice to the Commission; and make timetables and tariffs effective 10 or more days after this order is effective.

- d. Comply with General Orders Series 79, 98, 101, and 104, and the California Highway Patrol safety rules.
- e. Maintain accounting records in conformity with the Uniform System of Accounts.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS, AND SPECIFICATIONS.

Sonny O. Basso, an individual doing business as Lake Arrowhead Transportation Company, by the certificate of public convenience and necessity granted by the decision noted in the margin, is authorized to transport passengers between described points and places in the unincorporated portion of that territory of San Bernardino County near the City of San Bernardino, commonly known as the Lake Arrowhead recreation area, over and along the routes described, subject, however, to the authority of this Commission to change or modify the routes at any time and subject to the following provisions:

- (a) Motor vehicles may be turned at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersections, in accordance with local traffic regulations.
- (b) When route descriptions are given in one direction, they apply to operation in either direction unless otherwise indicated.
- (c) The applicant's tariff publication shall contain clear and concise statements of rules and individual fares for the authority which is being sought in a manner that will enable patrons to determine in advance what the charges for the service should be.
