O P I N I O N

Kenneth C. Hanan, an individual doing business as Ken Hanan Trucking, seeks a dump truck carrier permit to operate in the Counties of Shasta, Lassen, Tehama, Plumas, and Butte. Notice of filing of the application appeared in the Commission's Daily Calendar of March 12, 1982. Copies of the application were served on the California Dump Truck Owners Association and California Trucking Association, as well as on a number of associations of carriers with whom Hanan is likely to compete. No protest to the application has been received.

Hanan currently conducts operations under authority of a highway contract carrier permit and an agricultural carrier permit in File No. T-92,193. His place of business is at Johnson Park near Burney. Hanan certifies that he has resided in California not less than 90 days preceding this filing. His latest financial statement shows a net worth of \$282,001. A certificate of support for Hanan's application was submitted by Venture II, Ltd. of Burney, California.

Findings of Fact

1. Hanan is a fit and proper person to receive a permit as a dump truck carrier and has the experience and financial ability to perform the proposed operation.
2. Hanan's equipment will not endanger the safety of highways nor impair the condition or maintenance of them, either directly or indirectly.
3. Hanan's proposed operation will not unnecessarily burden the public highways, is necessary to serve the public, and will not impair the ability of presently permitted dump truck carriers to provide adequate service at the lowest possible reasonable rates.
4. Hanan has been a California resident for not less than 90 days preceding this filing.
5. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.
6. The following order complies with the guidelines in the Commission's Energy Efficiency Plan.
7. A public hearing is not necessary.

Conclusion of Law

The application should be granted. The effective date of the following order should be the date of signature to be consistent with issuance of permits to other classes of carriers.

O R D E R


IT IS ORDERED that upon applicant's compliance with the Commission's General Order Series 100 the Executive Director shall issue a dump truck carrier permit to Kenneth C. Hanan, an individual, authorizing operations within and between all points in the Counties of Shasta, Lassen, Tehama, Plumas, and Butte.
