ORDER TO SHOW CAUSE

On May 27, 1982, the City of Fresno (Fresno) filed a petition under Public Utilities (PU) Code §§ 1401 et seq. requesting that the Commission fix the just compensation which shall be paid by Fresno for the lands, property, and rights of the Kavanagh Vista Water Company. Such lands, property, and rights consist of water supply facilities, pumping facilities, transmission and distribution facilities, land and land rights, and general plant structures which are more fully defined and described in Exhibits A, B, and C, attached to the petition.

Therefore, IT IS ORDERED that under PU Code § 1405:

1. Kavanagh Vista Water Company, Francis H. Ferraro, Dovie M. Ferraro, and such other persons and corporations as may own or claim rights to the lands, property, and rights described above shall appear before the Commission at 9:30 a.m. on Wednesday, July 21, 1982, in the Commission Courtroom, State Building, 350 McAllister Street, San Francisco, California, to show cause, if any they have, why the Commission should not proceed to hear the petition and to fix the just compensation to be paid for such lands, property, and rights.
2. The hearing on July 21, 1982 shall be a prehearing conference and shall be for the purpose of:

- a. Identifying and simplifying the issues;
- b. Arranging for the exchange of proposed exhibits or prepared expert testimony;
- c. Identifying witnesses;
- d. Arriving at stipulations;
- e. Scheduling further hearing dates;
- f. Arriving at agreements for the completion of discovery procedures;
- g. Determining the extra costs to be incurred by the Commission to comply with the requirements of Chapter 8 of Part 1 of Division 1 of the Public Utilities Code and the schedule of payments to be made by Fresno; and
- h. Discussing such other matters as may expedite the orderly conduct and disposition of the proceeding.


