<u>O P I N I O N</u>

Ronald I. Schall, an individual, doing business as Ron Schall Trucking, has requested a permit as a dump truck carrier to operate in the Counties of Lassen, Plumas, Tehama, Shasta, and Modoc.

Our Transportation Division has examined the file, found that it contains information to support the required findings and recommended that the application be granted.

Copies of the application were served on California Carriers Association, California Dump Truck Owners' Association, California Trucking Association, Highway Carriers Association, Associated Independent Owner-Operators, Inc., Southern California Rock Products Association, Aggregates & Concrete Association of Northern California, Inc., and California Asphalt Pavement Association. Notice of filing appeared on the Commission's Daily Calendar of April 2, 1982. No protests have been received.

Schall currently operates under authority of a highway common carrier certificate and heavy-specialized and agricultural carrier permits under File T-114,894. He presently operates one tractor and semitrailer. As of March 12, 1982, Schall reports total assets of \$181,550, and a net worth of \$110,700. He has certified that he has resided in California not less than 90 days preceding this filing.

A certificate of support for Schall's application was submitted by Fred Bollman, vice president of Lassen Sand & Gravel, located in Susanville, California. This shipper states that it will engage Schall for 1,500 hours in the proposed counties during the first year of operations.

Findings of Fact

- 1. Applicant:
 - a. Is a fit and proper person to receive a permit to operate as a dump truck carrier.
 - b. Has sufficient operating knowledge and financial ability to initiate and continue the proposed operation.
 - c. Has demonstrated that the privilege sought:
 - Will not endanger the safety of the public or interfere with the public use of the public highways or impair the condition or maintenance of them, directly or indirectly.
 - (2) Will not unnecessarily burden the public highways.
 - (3) Is necessary to serve the public and will not impair the ability of presently permitted dump truck carriers to provide adequate service at the lowest possible reasonable rate.

2. Applicant has resided in the State of California for not less than 90 days preceding the filing of this application.

3. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

4. The following order complies with the Commission's Energy Efficiency Plan.

5. A public hearing is not necessary. Conclusions of Law

1. Applicant should be granted a dump truck carrier permit authorizing operations within and between points in the Counties of Lassen, Plumas, Tehama, Shasta, and Modoc.
