# ORDER GRANTING LIMITED REHEARING AND MODIFYING DECISION 82-05-038

A petition for rehearing for purposes of reconsideration and modification of Decision (D.) 82-05-038 has been filed by Citizens Utilities Company of California (Citizens). The Commission has considered each and every allegation of the petition and finds that the decision should be modified to delete therefrom the requirement that Citizens file advice letters for 1983 and 1984 rates and to authorize Citizens to file the revised schedule attached to this order, which includes rates for 1983 and 1984.

The Commission on its own motion hereby grants rehearing on the issue of the proper method of calculating compensation for the deferral in revenue, including the proper interest rate. Therefore,

IT IS ORDERED that,

- 1. D.82-05-038 is modified as follows:
  - (a) ordering paragraphs 1, 2, and 3 on pages 16 and 17, mimeo, are deleted.
  - (b) Appendixes A and B are hereby cancelled.
  - (c) on page 16, mimeo, the following paragraph is added as ordering paragraph 1:

"Citizens Utilities Company of California (Felton Water District) is authorized to file the revised schedule attached to this order as Appendix A and to concurrently cancel its present schedules for such service. This filing shall comply with General Order No. 96-A. The effective date of the revised schedules shall be four days after the date of filing."

2. Rehearing of D.82-05-038 is granted, limited to the filing of concurrent briefs, due 60 days from the date hereof, by the parties hereto. Said briefs are limited to the issue of the proper method of compensating Citizens for the deferral of revenues, including the proper interest rate.
