ORDER MODIFYING DECISION 82-06-048

An application for rehearing of Decision (D.) 82-06-048 has been filed by Lorrie's Travel & Tours, Inc. We have carefully considered every allegation of error and request for modification of the above decision and are of the opinion that good cause for rehearing has not been shown. However, portions of the Opinion and the attached Certificate of Public Convenience and Necessity should be modified. Therefore,

IT IS ORDERED that D.82-06-048 is modified as follows:

1. In the first sentence of the Opinion of Page 1 delete "in mini vans".
2. Delete the first sentence of the third paragraph on Page 2.

3. In the first sentence of the fourth paragraph on Page 2 delete "in mini vans". Also delete the entire second sentence in that paragraph.

4. The attached First Revised Page 2 of of PSC 1003 replaces Original Page 2.

5. The attached First Revised Page 3 of PSC 1003 replaces Page 3. Section I.e. is deleted and replaced by revised I.e.

6. Rehearing of D.82-06-048 as modified herein is denied.



SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS,  
AND SPECIFICATIONS.

This certificate supersedes all authority previously granted to Lorrie's Travel & Tours, Inc., to operate as a passenger stage corporation.

Lorrie's Travel & Tours, Inc., by the certificate of public convenience and necessity granted by the decision noted in the margin, is authorized as a passenger stage corporation to transport passengers and their baggage between areas located in San Francisco and the San Francisco International Airport and the Oakland International Airport, over and along the described routes, subject to the following provisions. These authorizations are subject, however, to the authority of this Commission to change or modify the routes or territories at any time and subject to the following provisions:

- a. The term "on-call" as used refers to service which is authorized to be rendered dependent on the demand of passengers. The tariffs and timetables shall show the conditions under which each authorized on-call service will be rendered.

- c. No passengers shall be transported except those having point of origin or destination at San Francisco International Airport or the Oakland International Airport.
- d. All passengers transported to or from the Oakland International Airport shall have origin or destination in Territory 1.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS,  
AND SPECIFICATIONS. (Continued)

- \*e. Operations from Territory 1 to San Francisco International Airport shall be conducted on an on-call basis. Operations from San Francisco International Airport shall be conducted on a scheduled basis.
- f. Operations between Territory 2 and San Francisco International Airport shall only be conducted on an on-call basis.
- g. Operations between Territory 1 and Oakland International Airport shall only be conducted on an on-call basis.
- h. When route descriptions are given in one direction, they apply to operation in either direction unless otherwise indicated.
