BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

In the matter of Application of the Private Industry Council of Ventura County, Inc. for authority to operate as a passenger stage corporation to provide home to work service between points in Camarillo, Fillmore, Oxnard, Santa Paula, Saticoy and Simi Valley and Newbury Park and Westlake Village in Ventura and Los Angeles Counties.

O P I N I O N

By Decision 93660 dated October 20, 1981, in Application 60956, Private Industry Council of Ventura County (applicant) was granted a temporary certificate of public convenience and necessity (PSC-1191) to establish a passenger stage corporation for the operation of home-to-work bus service between points in Ventura County and Thousand Oaks.

By this application, applicant seeks to obtain permanent authority for its existing temporary authority.

No other carrier is operating the service proposed by applicant.

Applicant intends to provide this service under contract with an existing charter-party certificated carrier.

Applicant's proposed fare is \$7.00 per week for each passenger.

The application was listed on the Commission's Daily Calendar. The Commission's Transportation Division staff has reviewed the application and recommends that in the absence of protest or request for public hearing, it be granted by ex parte order. No protest has been received.

Home-to-work commuter buses play an important role in providing increased public transportation and helping to relieve the energy shortage. Because there is a continuing need for these important passenger services, this order should be effective immediately.

Findings of Fact

1. The applicant has the ability and financial resources to perform the proposed service.
2. The proposed fare is reasonable.
3. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

Conclusion of Law

Public convenience and necessity have been demonstrated and the application should be granted. A public hearing is not necessary.

Only the amount paid to the State for operative rights may be used in rate fixing. The State may grant any number of rights and may cancel or modify the monopoly feature of these rights at any time.

O R D E R

IT IS ORDERED that:

1. A certificate of public convenience and necessity is granted to Private Industry Council of Ventura County authorizing it to conduct operations as a passenger stage corporation, as defined in PU Code Section 226, between the points and over the routes set forth in Appendix PSC-1191, to transport persons and their baggage.
2. Applicant shall:
 - a. File a written acceptance of this certificate within 30 days after this order is effective.


- b. Establish the authorized service and file tariffs and timetables within 120 days after this order is effective.
- c. State in its tariffs and timetables when the service will start; allow at least 10 days' notice to the Commission; and make timetables and tariffs effective 10 or more days after this order is effective.
- d. Comply with General Orders Series 79,98, 101, and 104, and the California Highway Patrol safety rules.
- e. Maintain accounting records in conformity with the Uniform System of Accounts.

This order is effective today.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS,
LIMITATIONS, AND SPECIFICATIONS.

Private Industry Council of Ventura County, by the certificate of public convenience and necessity granted by the decision noted in the margin, is authorized as a passenger stage corporation to transport passengers, and their baggage only, between Oxnard, Camarillo, Thousand Oaks, Simi Valley, Moorpark, Fillmore, Santa Paula, and adjacent territories, with stops over and along the routes described, subject, however, to the authority of this Commission to change or modify the routes at any time and subject to the following provisions:

- a. Motor vehicles may be turned at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersections, in accordance with local traffic regulations.
- b. When route descriptions are given in one direction, they apply to operation in either direction unless otherwise indicated.
- c. Passengers should be boarded or disembarked at the authorized service points only, as set forth in each route description below.
- d. For operating purposes, carrier may operate buses to skip certain stops on certain schedules, provided that all authorized service points receive adequate service.
