### FINAL OPINION

## Summary

This order confirms the tentative findings in Decision (D.) 82-06-022 that two agreements between Pacific Gas and Electric Company (PG&E) and the Regents of the University of California (Regents), reached in settlement of litigation, are reasonable. The order also makes final the tentative authority granted to PG&E to enter into the agreements. The proceeding is concluded. Discussion

By D.82-06-022, dated June 2, 1982, the Commission authorized PG&E to enter into two agreements with the Regents which were reached in a settlement of a law suit that Regents had brought against PG&E.

D.82-06-022 provided that this proceeding remain open so that the Commission's staff might complete analysis of the provisions of the agreements.

By a memorandum dated September 20, 1982, the chief of the Commission's Rate Design and Economics Branch has advised the administrative law judge (ALJ) to whom this proceeding is now referred that the agreements appear reasonable and that the staff recommended that they be approved. This memorandum was marked and received into evidence by the ALJ as Exhibit 1.

The Commission will confirm its tentative finding and conclusion in D.82-06-022 that the agreements are reasonable and that approval should be granted.

## Findings of Fact

- 1. The two agreements for which approval is sought in this application will result in just and reasonable rates and provisions.
- 2. Any increases in rates or charges resulting from the terms of the agreements are justified.

### Conclusion of Law

The authority granted in D.82-06-022 should be confirmed and made final.

## FINAL ORDER

IT IS ORDERED that:

- l. The tentative authority granted to Pacific Gas and Electric Company by 0.82-06-022 to enter into the two agreements attached to Application 82-05-54 is confirmed and made final.
  - This proceeding is concluded.
