<u>O P I N I O N</u>

Applicants Riad Daoudi and Arzene Daoudi, dba AAA Airport Service, request authority to operate as a passenger stage corporation between points in Los Angeles-Orange County, on the one hand, and the Los Angeles International Airport (LAX)-Orange County Airport (John Wayne Airport)-Long Beach Airport and Ontario Airport, on the other hand. Applicants' principal place of business is located in Whittier, California.

Applicants propose to perform an "on-call" service on a 7-day per week basis carrying passengers originating at or destined to LAX, Long Beach Airport, Ontario Airport, and John Wayne Airport, using two 5-passenger Volkswagen vans and a 7-passenger Ford station wagon. Applicants anticipate carrying passengers from the following locations: Whittier, Downey, Montebello, Pico Rivera, Commerce, Norwalk, La Mirada, Buena Park, Hacienda Heights, La Habra, Rowland Heights, Fullerton, and Brea. Applicants' vehicles will be garaged, serviced, and maintained in their vehicle service facility located at their

headquarters, 13553 East Whittier Boulevard, Whittier. 90605. Applicants contend that as the result of the reduction in the use of private vehicles by the passengers whom they intend to carry in their proposed service, the authority sought in this application will have no significant adverse effect upon the environment.

Notice of the filing of this application appeared in the Commission's Daily Transportation Calendar of August 5, 1982. In addition, a copy of this application was served upon various government entities and upon other passenger stage corporations which may have an interest in this matter. No protests to the application have been received.

Applicants propose to charge \$25 for one, two, or three people to all of the above-named airports from the communities of Whittier, Downey, Montebello, Pico Rivera, Commerce, and Norwalk, and \$26 for parties of one, two, or three people to the abovementioned airports from the communities of La Mirada, Buena Park, Hacienda Heights, La Habra, Rowland Heights, Fullerton, and Brea. Applicants propose to obtain liability insurance in connection with their proposed operation in amounts that exceed the minimum required under the Commission's General Order 101-C. The financial information attached to the application shows assets of \$175,000, which include \$60,000 in cash, and liabilities of \$25,000, for a net worth of \$150,000.

Findings of Fact

1. Applicants have the ability, equipment, and financial resources to perform the proposed service.

2. Public convenience and necessity require the service proposed by applicants.



3. A public hearing is not necessary.

4. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

Conclusions of Law

- f. Maintain accounting records in conformity with the Uniform System of Accounts.
