ORDER MODIFYING
DECISION (D.) 82-09-110
AND DENYING REHEARING

An application for rehearing of D.82-09-110 has been filed by California Building Industry Association (CBIA). We have carefully considered each and every allegation of error in CBIA's application and are of the opinion that no good cause for granting rehearing has been shown.

CBIA points out that D.82-09-110 did not resolve comments and a protest it had filed with respect to the Utility Committee's draft rules and San Diego Gas & Electric Co.'s Advice Letter No. 567-E. In view of the rehearing granted by D.82-09-110, it was not appropriate to do so. In our forthcoming order on rehearing of D.82-09-110 we expect to respond to all of CBIA's filings as well as those of other parties which are still under consideration.

Finally, it has come to our attention that there are some arithmetical errors in D.82-09-110. Also some modifications are needed to make it clear that the one-third phasing program applies to all new customers, not merely to new residential and priority one commercial customers. This was our intention in D.82-04-068. Therefore, good cause appearing,

IT IS ORDERED that:

1. D.82-09-110 is modified as follows:


- (a) On page 24, mimeo, in the fifth line of the last paragraph, the number "\$155" is deleted and replaced with "\$310."
- (b) On page 25, mimeo, in the third line of the page, the number "\$259" is deleted and replaced with "\$518" and the number "\$22" is deleted and replaced with "\$44."
- (c) Subsections 8), 9) and 10) are added to Ordering Paragraph 5 to read as follows:
 - 8) On page 24, delete the first paragraph.
 - 9) On page 20, delete the last paragraph.
 - 10) Delete Finding No. 18 on page 58 and reduce by one the numbers of all subsequent findings.

2. Rehearing of D.82-09-110 as modified herein is denied.
