ORDER OF DISMISSAL

Applicant Les Paul's Tours requested a certificate of public convenience and necessity under Public Utilities Code Section 1031 to conduct sightseeing-tour operations. Application (A.) 82-08-30 is signed by applicant's president, Lessie Paul Yarbrough. However, applicant does not indicate whether it is an individual, a partnership, or a corporation. The application does not contain applicant's telephone number. An Administrative Law Judge's Ruling dated December 13, 1982 states:

"In order to complete the processing of your Application 82-08-30 for a certificate of public convenience and necessity to operate a passenger service, the Commission requires that you furnish the following information...

"Is applicant an individual, a partnership, or a corporation?

"If applicant is an individual, is the correct name of applicant Lessie Paul Yarbrough doing business as Les Paul's Tours?

"If applicant is a partnership, list all of the partners and obtain their signatures on a sworn statement stating they are members of a partnership doing business as Les Paul's Tours.

"If applicant is a corporation, provide a copy of the filed articles of incorporation.

"Clarify whose assets, liabilities, and income are shown on Exhibit H, attached to the application.

"Provide the Commission with your current address and phone number."

That ruling was mailed to Les Paul's Tours at the address applicant listed in its application. It was returned to the Commission by the United States Postal Service with a stamp stating "UNDELIVERABLE AS ADDRESSED UNABLE TO FORWARD".

Due to applicant's failure to provide information needed to process A.82-08-30, the application should be dismissed without prejudice.

Findings of Fact

1. A.82-08-30 was not completed in compliance with our Rules of Practice and Procedure.
2. The Commission is unable to contact applicant to obtain needed information.

Conclusion of Law

The application should be dismissed without prejudice.


IT IS ORDERED that Application 82-08-30 is dismissed
