INTERIM OPINION

Applicant is a Sacramento resident and a tour guide. She has applied for a certificate of public convenience and necessity under Public Utilities Code Section 1031 to conduct sightseeing-tour operations.

Applicant will be operating from one to eight different tours, depending on demand for them. All tours will be 3 to 4 hours in length and will be run between the hours of 9:00 a.m. to 12:00 p.m., 12:30 p.m. to 4:30 p.m., and 6:30 p.m. to 10:30 p.m. Pickups will be made at hotels in the Sacramento and West Sacramento areas. Fares will range from \$10.00 to \$40.00 per person. Tours will visit the following points of interest:

- Tour 1. Old Sacramento, the State Capitol, Sutter's Fort, and the Governor's Mansion_
 - Tour 2. A grand tour of old Sacramento, expanded to include Crocker Art Museum, The Capitol, and
 - Sacramento State University.

- Tour 3. Town of Folsom, Folsom Prison, and Folsom Dam.
- Tour 4. Heritage Farms Cheese Factory and Frasinetti Winery.
- Tour 5. A visit to River City Brewing Co. and the California Almond Growers Exchange to tour and taste.
- Tour 6. A cruise on the Sacramento River and attendance at a nightclub show in old Sacramento.
- Tour 7. A drive around the islands of the Delta and a visit to the historic Ryde Hotel, with a tour of Locke and Freeport.
- Tour 8. The Railroad Museum, the State Capitol, and the Governor's Mansion.

Service is to be provided by one or more new or late model 15-passenger vans. Tours will be divided into groups of 14, or less, and all drivers will be qualified to guide the tours. There are no other tour operators performing the service proposed by applicant, although at least one company provides a tour of old Sacramento. Applicant has included a statement of financial ability which states that applicant has in excess of \$5,000 as a cash reserve and available to invest in the business.

The County Clerks of Sacramento and Yolo Counties were mailed copies of the application; copies were also mailed to the city clerks in Sacramento and Folsom. No operators were served, but the filing of the application was noted on the Commission's Daily Calendar of October 27, 1982. No protests have been filed.

In Decision (D.) 93726 in Application 59818 et al. issued November 13, 1981, we found that sightseeing-tour service over a

INTERIM ORDER

IT IS ORDERED that:

1. Barbara Malakoff is granted a temporary certificate of public convenience and necessity to operate a sightseeing-tour service over the routes

proposed in the application until further order of the Commission and is assigned Passenger Stage Corporation PSC-1284. A permanent certificate prepared by this Commission may be issued by a final order.

Applicant shall:

- a. File a written acceptance of this authority within 30 days after this order is effective.
- b. Establish the authorized service and file tariffs and timetables within 120 days after this order is effective.
- c. State in her tariffs and timetables when service will start; allow at least 10 days' notice to the Commission; and make timetables and tariffs effective 10 or more days after this order is effective.
- Comply with General Orders Series 79, 98, 101, and 104, and the California Highway Patrol safety rules.
- e. Maintain accounting records in conformity with the Uniform System of Accounts.
