It has come to the Commission's attention that Ordering Paragraph 1 of Decision (D.) 83-04-046 does not reflect the intent of that decision to increase by 12.9% all rates and charges as shown in Exhibit A to the amended application. D.83-04-046 authorized increases only in one tariff maintained by applicant. Ordering Paragraph 1 should be deleted and a revised ordering paragraph substituted.

IT IS ORDERED that:

1. Ordering Paragraph 1 of D.83-04-046 dated April 6, 1983 is deleted and replaced with the following revised Ordering Paragraph 1 shown below:

"Four Corners Pipe Line Company is authorized to increase the rates and charges in its Tariffs Cal. PUC 22, 24, 25, 27, 28, 29, 33, 40, 43, 44, 45, 47, 48, 49, 51, 52 and successive issues thereof, between points of origin and destination shown in Exhibit A to its amended application by 12.9%. The increase shall be subject to refund pending a final decision in this matter."

2. The tariff publication authorized in the preceding paragraph may be filed with the Commission on the effective date of this order to become effective 5 days after the date of filing.

3. In all other respects, D.83-04-046, as amended, shall remain in full force and effect.

This order is effective today.
