## ORDER OF REVOCATION

Commission Decision (D.) 82-07-084, dated July 21, 1982, granted Igor Greenberg, Yevgeny Osherovich, and Boris Gorbis, a partnership, doing business as Maxi Taxi Company (Maxi Taxi) (PSC-1239), a certificate of public convenience and necessity as a passenger stage corporation to operate a passenger bus service in Los Angeles County. Ordering Paragraph 3(b) of D.82-07-084 required Maxi Taxi to file tariffs and timetables and establish service within 120 days of the date of the order, namely by November 18, 1982.

Maxi Taxi did not establish service by November 18, 1982. Instead, Boris Gorbis, on behalf of the partnership, wrote to the Commission and asked for an extension of time to institute service. In Resolution PE-446, PR 82.10 dated January 12, 1983, the Commission granted an extension until March 31, 1983. Maxi Taxi did not establish service or file tariffs and timetables by that date, and has not yet done so. It has also not applied for a further extension of time.

## Findings of Fact

1. Maxi Taxi is a passenger stage corporation (PSC-1239) authorized by D.82-07-084 to operate a passenger bus service in Los Angeles County.

2. Ordering Paragraph 3(b) of D.82-07-084 required Maxi Taxi to file tariffs and timetables and establish service by November 18, 1982. Maxi Taxi did not do so.

3. Following a request by Boris Gorbis, the Commission in Resolution PE-446, PR 82.10, granted Maxi Taxi an extension of time until March 31, 1983 to file tariffs and timetables and establish service. Maxi Taxi again did not do so.

4. Maxi Taxi has not applied for a further extension of time.

5. Revocation of the certificate authorizing Maxi Taxi to operate a passenger bus service in Los Angeles County would not be adverse to the public interest.

Conclusions of Law

1. Maxi Taxi has not complied with Ordering Paragraph 3(b) of D.82-07-084, as amended by Resolution PE-446, PR 82.10.

2. Failure to comply with Commission orders constitutes good cause to revoke Maxi Taxi's certificate as a passenger stage corporation.

IT IS ORDERED that:

1. The certificate of public convenience and necessity as a passenger stage corporation granted to Igor Greenberg, Yevgeny Osherovich, and Boris Gorbis for the purpose of operating a passenger bus service in Los Angeles County, as authorized by D.82-07-084, is revoked upon the effective date of this order.

2. Appendix PSC-1239 of D.82-07-084 is cancelled.
