ORDER EXTENDING EFFECTIVE DATE OF TARIFFS

Decision (D.) 82-12-094 of December 15, 1982, in this proceeding among other things, ordered that tariffs of respondent utilities filed in compliance with the decision were to become effective on June 15, 1983, unless further postponed.

D.83-06-013 dated June 1, 1983, granted Pacific Gas and Electric Company's motion to postpone to July 15, 1983 the effective date of the new tariffs because of potential hardships that could be caused by proposed legislation in Senate Bill 48 (SB 48). SB 48 would retain the currently effective tariffs while the Legislature studies the effects of revisions to the line extension rules. SB 48 has passed the Senate and is still under consideration in the Assembly. A further postponement beyond July 15 would enable us to better ascertain legislative intent and avoid potential hardship upon the utilities and their customers seeking extensions.

The tariffs, as revised by the following Commission resolutions adopted June 1, 1983 should not be put into effect until September 30, 1983:

D.83-06-013 dated June 1, 1983, granted Pacific Gas and Electric Company's motion to postpone to July 15, 1983 the effective date of the new tariffs because of potential hardships that could be caused by proposed legislation in Senate Bill 48 (SB 48). SB 48 would retain the currently effective tariffs while the Legislature studies the effects of revisions to the line extension rules. SB 48 has passed the Senate and is still under consideration in the Assembly. A further postponement—for—60—days beyond July 15 would enable us to better ascertain legislative intent and avoid potential hardship upon the utilities and their customers seeking extensions.
