SUPPLEMENTAL ORDER

By Decision 82-06-011 dated June 2, 1982 in Application 82-05-01, the Commission authorized Southern California Edison Company (Edison) to issue up to \$200,000,000 of its First and Refunding Mortgage Bonds, debentures, convertible debentures, promissory notes, and/or other evidences of indebtedness (collectively referred to as Debt Securities). Edison paid \$66,000, the fee set by PU Code Section 1904(b), after taking credit for the retirement of \$40,000,000 principal amount of First and Refunding

A. 82-05-01 RR/KLH/AV/WPSC

Mortgage Bonds, Series I, due July 1, 1982 and \$40,000,000 principal amount of First and Refunding Mortgage Bonds, Series J, due September 1, 1982.

Edison informed the Commission by letter dated June 28, 1983 that it issued only \$125,000,000 of these Debt Securities. Edison requests a refund of \$37,500 applicable to the \$75,000,000 of Debt Securities, which were authorized but not issued.

Therefore, good cause appearing,


IT IS ORDERED that the Executive Director shall refund \$37,500 to Southern California Edison Company.
