ORDER OF DISMISSAL

The Aptec Corporation, a California corporation, filed Application 61020, dated October 30, 1981, seeking certain exemptions from the Commission's Decision 92251, as amended, concerning the use of heat for freeze protection in its solar systems.

The Energy Conservation Branch (ECB) telephoned Aptec Corporation shortly thereafter requesting that the corporation provide test data on the Heliophase Solar Heating System. These test data were necessary in order for the staff to make proper evaluation of applicant's system and for the corporation to participate in the Demonstration Solar Financing Program. The staff received no data.

On September 29, 1982 the Commission sent a letter to applicant requesting a status report on this matter; again, to no avail. Subsequently, on August 2, 1983, staff telephoned Howard Helfman of Aptec apprising him of the pending termination of the Demonstration Solar Financing Program on September 15, 1983. Shortly thereafter, Mr. M. R. Goodman, President of the Company, called the staff indicating he would advise the Commission why he would no longer pursue the matter. No response to this conversation has been received to date.

We believe the applicant had ample time to comply with our request for data. This it failed to do. Since the program terminates on September 15, 1983, it is incumbent upon the Commission to dispose of this matter.

IT IS ORDERED that Application 61020 is dismissed. This order becomes effective 30 days from today.
