## OPINION

Lane Drayage, Inc., (Lane) seeks authority to increase its rates by amounts up to 15%. Lane has adopted Transition Tariffs 1-B, 2, 9-B, 11-A, 15, 19, Minimum Rate Tariffs 8-A, 14-A, Exception Ratings Tariff 1 (ERT 1) and Distance Table 8 (DT 8) as its own common carrier tariffs.

As justification for the proposed increases, applicant cites higher operating costs it is experiencing, the most significant being an increase in labor costs. In establishing the increases, Lane assertedly recognizes the forces of competition within the market and expects the increased rates will be within the zone of reasonableness.

The applicant has prepared financial data for a test period ending January 31, 1983. From that data, the staff has prepared a comparison of Lane's financial position using the present costs being experienced compared with revenue earned in 1982 and with the projected 1983 revenue including the sought increase.

Applicant estimates that the sought increases would increase its California intrastate annual gross revenue by about \$51,936.

The application was listed on the Commission's Daily Calendar of March 24, 1983. No objection to the granting of the application has been received.

The proposal is not a major action significantly affecting energy efficiency within the meaning of Sections 3502.1 and 3502.2 of the Public Utilities (PU) Code.

### Findings of Fact

- 1. Applicant's rates were last adjusted on April 20, 1980. Since then it has experienced increases in operating expenses, the most significant being the increased cost of labor.
- 2. An increase in rates by 15% is needed to offset the present costs being experienced.
- 3. Under the increases, applicant estimates it will realize additional revenue of \$51.936.
  - 4. The increases resulting from this proposal are justified.
- 5. Limited authority to depart from the provisions of PU Code Section 461.5 is justified.
- 6. The following order has no reasonably foreseeable impact upon the energy efficiency of highway common carriers.
  - 7. A public hearing is not necessary.

# Conclusions of Law

- 1. The application should be granted.
- 2. The tariff pages to be published should be made effective no sooner than the fifth day after the effective date of this order.

## ORDER

#### IT IS ORDERED that:

- 1. Lane Drayage, Inc. is authorized to increase its rates by amounts up to 15% by amending its adoption notice and attaching revised surcharge supplements to its adopted Transition Tariffs 1-B. 2. 9-B, 11-A, 15, Minimum Rate Tariffs 8-A and 14-A.
- 2. Tariff publications authorized to be made as a result of this order shall be filed not earlier than the effective date of this order and may be made effective not earlier than 5 days after the effective date of this order on not less than 5 days' notice to the Commission and to the public.
- 3. Lane Drayage, Inc. in establishing and maintaining the rates and charges authorized by this order, is authorized to depart from the provisions of PU Code Section 461.5 to the extent necessary to adjust long- and short-haul departures now maintained under outstanding authorizations; such outstanding authorizations are modified only to the extent necessary to comply with this order; and schedules containing the rates published under this authority shall make reference to the prior orders authorizing long- and short-haul departures and to this order.

## ORDER
