In the matter of the Application of Guiton Charter Lines., for permanent authority to operate service between Contra Costa County and San Francisco.

Application 83-08-50 (Filed August 18, 1983)

## OPINION

By Decision 82-10-66 dated October 20, 1982 in Application 82-09-42, Andre Guiton (applicant), doing business as Guiton Charter Lines, was granted a temporary certificate of public convenience and necessity (PSC-1257) as a passenger stage corporation for the operation of home-to-work bus service between points in Contra Costa County and San Francisco. This authority expires October 20, 1983.

In this application, Andre Guiton is seeking permanent authority between the above points. Applicant intends to provide this service using its currently owned fleet of equipment. No other carrier is operating the service proposed by applicant.

Applicant's proposed weekly passenger fares for a 20-ride book (60 day max. life) varies with the distance traveled and ranges from \$40 to \$55.

The application was listed in the Commission's Daily Calendar of August 24, 1983. The Commission's Transportation Division staff has reviewed the application and recommends that in the absence of protest or request for public hearing, it be granted by ex parte order. No protest has been received.

## Findings of Fact

- 1. Applicant has the ability, equipment, and financial resources to perform the proposed service.
  - 2. The proposed fares are reasonable.
- 3. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment. The order below should be effective today to avoid an unnecessary interruption in this important passenger stage service due to the impending expiration of applicant's present temporary authority.

### Conclusions of Law

- 1. A public hearing is not necessary.
- 2. Public convenience and necessity have been demonstrated and the application should be granted.
- 3. Because there is a continuing need for these important passenger services, this order should be effective today.

Only the amount paid to the State for operative rights may be used in rate fixing. The State may grant any number of rights and may cancel or modify the monopoly features of these rights at any time.

#### ORDER

#### IT IS ORDERED that:

- 1. A certificate of public convenience and necessity is granted to Andre Guiton authorizing him to conduct operations as a passenger stage corporation, as defined in PU Code Section 226, to transport persons and baggage. Appendix 1257 is amended by replacing Original Title Page, First Revised Page 1, Original Pages 2 and 3 with First Revised Title Page, Second Revised Page 1, and First Revised Pages 2 and 3, attached.
  - 2. Applicant shall:
    - a. File a written acceptance of this certificate within 30 days after this order is effective.
    - b. Establish the authorized service and file tariffs and timetables within 120 days after this order is effective.
    - c. State in his tariffs and timetables when the service will start; allow at least 10 days' notice to the Commission; and make timetables and tariffs effective 10 or more days after this order is effective.

- d. Comply with General Orders Series 79, 98, 101, and 104, and the California Highway Patrol safety rules.
- e. Maintain accounting records in conformity with the Uniform System of Accounts.

This order is effective today.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS LIMITATIONS, AND SPECIFICATIONS.

Andre Guiton, by the certificate of public convenience and necessity granted by the decision noted in the margin, is authorized as a passenger stage corporation to transport hometo-work passengers between the points and along the routes hereinafter described subject, however, to the authority of this Commission to change or modify this authority at any time and subject to the following provisions:

- a. All transportation of passengers shall originate at and shall be destined to the service points specified in Section 2.
- b. When route descriptions are given in one direction, they apply to operation in either direction unless otherwise indicated.
- \*c. Intentionally left blank.
- d. Schedules on Route N may commence at either Napa or Vallejo provided adequate service is afforded to the entire route and, additionally, that at least one San Francisco roundtrip per day serves Napa and Imola.
