ORDER OF DISMISSAL

By letter dated July 29, 1983 the Commission staff advised Rex Crockett Corporation of America, Inc., doing business as R. C. Westway Stagelines, that its application was incomplete and requested applicant to contact staff to discuss the deficiencies in its application. On July 28, 1983 and August 11, 1983 applicant's president informed staff that he would send a letter withdrawing the application. Since applicant did not send a letter withdrawing the application, staff recommended that the application be dismissed for lack of prosecution.

Findings of Fact

1. Staff advised applicant that its application was incomplete.
2. Applicant informed staff that it would send a letter to the Commission withdrawing its application.
3. Applicant did not furnish additional information to the Commission to correct the deficiencies in its application.
4. Applicant did not file a written request to dismiss its application.

Conclusion of Law

The application should be dismissed for lack of prosecution by applicant.


