O P I N I O N

James D. Davis, dba Davis Trucking, requests a cement contract carrier permit to operate from all places in the State of California to all places in the Counties of Los Angeles, Riverside, Kern, Inyo, San Bernardino, Orange, San Diego, Ventura, and Imperial. Notice of the filing of the application appeared in the Daily Transportation Calendar of August 10, 1983. No protests have been filed.

Discussion

Applicant also holds authority as a highway contract carrier (T-115,497) and as a highway common carrier (GC-8115). He operates two tractors and three trailers. He claims a net worth of \$532,000 including \$2,700 of cash and \$8,700 of accounts receivable. His application is supported by a shipper who will need transportation to each of the named counties. This traffic is expected to provide \$15,600 in revenue annually.

Findings of Fact

1. Applicant:
  - a. Is a fit and proper person to receive a permit to operate as a cement contract carrier.
  - b. Has sufficient operating knowledge and financial ability to initiate and continue the proposed operation.

c. Has demonstrated that the privilege sought:

- (1) Will not endanger the safety of the public or interfere with the public use of the public highways or impair the condition or maintenance of them, directly or indirectly.
- (2) Will not unnecessarily burden the public highways.
- (3) Is necessary to serve the public and will not impair the ability of existing cement or cement contract carriers to provide adequate service at the lowest possible reasonable rates.

2. Applicant has resided in the State of California for at least the 90 days preceding the filing of this application.

3. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

4. The following order complies with the Commission's Energy Efficiency Plan.

5. A public hearing is not necessary.

Conclusions of Law

1. Applicant should be granted a cement contract carrier permit authorizing operations from all places in the State of California to all places in the Counties of Los Angeles, Riverside, Kern, Inyo, San Bernardino, Orange, San Diego, Ventura, and Imperial.

2. The following order should be effective today to be consistent with other permit grants.

O R D E R

IT IS ORDERED that the Executive Director shall issue a cement contract carrier permit to James D. Davis, authorizing operations from all places in the State of California to all places in the Counties of Los Angeles, Riverside, Kern, Inyo, San Bernardino, Orange, San Diego, Ventura, and Imperial upon compliance with General Order Series 100.


