ORDER GRANTING REHEARING

3. Minimum Rate Tariff 1-B (Appendix B to Decision 65834, as amended) is further amended by incorporating therein Supplement 25 which supplement is attached hereto and by this reference made a part hereof.
4. Minimum Rate Tariff 19 (Appendix A to Decision 41363, as amended) is further amended by incorporating therein Supplement 34 which supplement is attached hereto and by this reference made a part hereof.
5. This rehearing of D. 86380 shall be assigned number  
 OSH 372 in Case No. 5441.

The Executive Director is directed to cause appropriate notice of rehearing to be mailed at least ten (10) days before such rehearing.
