SUPPLEMENTAL OPINION

Ordering Paragraph 8 of Decision No. 85935, dated June 8, 1976, restricted Big Hill Water Co., Inc. from taking any further applications for service without first seeking authority from the Commission. This restriction was placed on the utility due to inadequate sizes of certain distribution mains.

By correspondence of September 4, 1976, the utility seeks authorization to add three new services to its Big Hill Division and by correspondence of September 27, 1976, it seeks authority to add one new service to its Monte Grande Division. Applicants for service from the Big Hill Division are Mr. Darrell Persels, Mr. Floyd Iverson and Mr. William P. Grimes. Application for service from the Monte Grande Division was made by Mr. Michael Condry. Of the three applications for service from the Big Hill Division, only two are in conformance with the requirements of General Order No. 103. These two are Mr. Persels and Mr. Iverson. To provide service to Mr. Grimes, the utility will have to upgrade the size of the existing distribution main from two inches to a minimum size of not less than four inches. Service to Mr. Condry in the Monte Grande Division conforms to the requirements of General Order No. 103.

Findings and Conclusions

With the exception of serving Mr. William P. Grimes from the Big Hill Division, the other applications for service are in conformance with G.O. No. 103. For the utility to serve Mr. Grimes and conform to the requirements of G.O. No. 103, the distribution main serving Mr. Grimes will have to be upgraded within six months after the effective date of this decision to a minimum size of not less than four inches.

SUPPLEMENTAL ORDER


IT IS ORDERED that:

1. Big Hill Water Co., Inc. is authorized to provide service to Messrs. Darrell Persels, and Floyd Iverson from its Big Hill Division and Mr. Michael Condry from its Monte Grande Division.


2. Service to Mr. William P. Grimes from the Big Hill Division is hereby authorized provided that Big Hill Water Co., Inc. upgrades the distribution main to serve Mr. Grimes to a minimum size of not less than four inches, within six months of the effective date of this decision, and notify the Commission, in writing, within thirty days after the completion of this upgrading.

The effective date of this order is the date hereof.
