ORDER OF REVOCATION

By Decision 75422, dated March 11, 1969 in Application 49376, Golden Sedan Service, Inc., was granted a Certificate of Public Convenience and Necessity (PSC-840) to operate as a passenger stage corporation between points in Santa Clara County and points within the Cities of Menlo Park and San Carlos, on the one hand and Oakland International Airport, San Francisco International Airport and San Jose Municipal Airport, on the other hand.

The Commission staff has been informed that Golden Sedan Service, Inc. is no longer exercising its passenger stage authority and that said authority has allegedly been sold to Airline Limousine Service, Inc. By letter dated May 20, 1976, the Commission staff informed Golden Sedan Service, Inc. that unless it filed a formal application to transfer its certificate within 20 days from the date of the letter, the Commission staff would take the necessary steps and recommend to the Commission that its certificate be revoked. Golden Sedan Service, Inc. has failed to respond to the letter.

Since October 1, 1975, Golden Sedan Service, Inc. has had no evidence on file with this Commission showing adequate protection against liability imposed by law for payment of damage for personal injury or property damage, as required by General Order 101-C.

It appears and the Commission finds that these matters constitute good cause for the revocation of the aforenamed certificate and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that the certificate should be revoked and that tariffs and timetables applicable to the service thereunder should be cancelled.

IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation, authorized by Decision 75422 in Application 49376, is hereby revoked and all effective tariffs and timetables on file with the Commission in the name of Golden Sedan Service, Inc. are cancelled upon the effective date of this order.
