## ORDER OF REVOCATION

By Decision 84399 dated May 6, 1975 in Application 55461, Robert O. Ernst, doing business as Ventura Limousine and Bus Service, was granted a Certificate of Public Convenience and Necessity to operate as a passenger stage corporation (PSC-967) between Ventura and Oxnard, on the one hand, and certain points in Los Angeles, Orange and San Bernardino Counties on the other hand.

Since July 8, 1976, Robert O. Ernst has had no evidence on file with this Commission showing adequate protection against liability imposed by law for payment of damage for personal injury or property damage, as required by General Order No. 101-C.

On November 18, 1976, the Commission staff issued a certified letter to Robert O. Ernst that the Commission staff was informed he was no longer exercising his authority and that the staff would recommend to the Commission that his authority be revoked should he fail to respond within ten days from the date of the letter. The Commission staff received a receipt from the U.S. Post Office that the letter was received and signed by R.O. Ernst on December 6, 1976. The Commission has not received any reply to the Commission staff's letter.

It appears and the Commission finds that these matters constitute good cause for the revocation of the aforenamed certificate and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that the certificate should be revoked and that tariffs and timetables applicable to the service

thereunder should be canceled.

IT IS ORDERED that the Certificate of Fublic Convenience and Necessity to operate as a passenger stage corporation authorized by Decision 84399 in Application 55461 is hereby revoked and all effective tariffs and timetables on file with the Commission in the name of Robert O. Ernst, doing business as Ventura Limousine and Bus Service, are canceled upon the effective date of this order.

The Executive Director shall mail a certified copy of this order to Robert O. Ernst at P.O. Box 279, Ventura, CA 93001, last known address as shown on the Commission's records.

The effective date of this order shall be the 20th day after the above mailing to Robert O. Ernst's last known address, unless before such effective date there shall have been filed with the Commission written response to this order requesting public hearing in which event the effective date of this order shall be stayed until further order of the Commission.
