SUPPLEMENTAL ORDER SETTING HEARING
AND CONSOLIDATING PROCEEDINGS

The Commission's Transportation Division has prepared exhibits containing proposed vehicle unit rates for inclusion in Minimum Rate Tariff 15 applicable to the transportation of salt, in bulk, and separate minimum vehicle unit rates for commodities,

in bulk, other than salt, in transfer end-dump truck equipment. These exhibits were received in evidence at the original hearing held in the above proceedings on December 14, 1976. Additionally, at the hearing the staff rate witness proposed that the outstanding deviations on salt, in bulk, in transfer end-dump equipment, be canceled. The deviations are in effect pending further order of the Commission and were not named as being part of the record.

The instant proceedings were consolidated for hearing on a common record with Cases 5437 and 7857 (Petitions for Modification 291 and 151) respectively. Accordingly, a public hearing should be held in the proceedings hereinbefore mentioned for the purpose of receiving evidence relative to the staff's proposal to cancel the less-than-minimum rate authorities granted in Application 52634 and Special Deviation Docket Application SDD-367.

IT IS ORDERED that a public hearing for the purpose indicated be held in the aforementioned consolidated proceedings and further consolidated with hearings in Application 52634 and Special Deviation Docket Application SDD-367 before Examiner Gagnon, Thursday March 17, 1977, at 10:00 a.m. in Room 1036, State Building, 2550 Mariposa Street, Fresno, California, at which time and place petitioners, applicants and all interested parties may appear and be heard.
