ORDER MODIFYING DECISION NO. 86803
AND DENYING REHEARING

On January 14, 1977, John L. Dutcher (a Commission employee) filed a petition for rehearing of Decision No. 86803. After reviewing each and every allegation the Commission is of the opinion that good cause for rehearing has not been shown. However, the Commission finds that modification of Decision No. 86803 and Appendix A attached thereto are necessary to correct typographical errors and to clarify certain references and statements.

THEREFORE, IT IS ORDERED that:

1. Rehearing of Decision No. 86803 is hereby denied.
2. Decision No. 86803 is modified as follows:
 - a. Line 35 of page 22 is modified to read: "the requirements of Article 2 of Chapter 7 of the Act."
 - b. Line 38 of page 29 is modified to read: "excluded by Section 13(b)(7) from the reporting requirements of the Commission's Conflict of Interest Code."
 - c. Line 21 of page 30 is modified to read: "substantially equivalent to the requirements of Article 2 of Chapter 7 of the Act,".

- d. Line 25 of page 40 is modified to read: "the requirements of Article 2 of Chapter 7 of the Political Reform Act of 1974."
3. Appendix A to Decision No. 86803 is modified as follows:
 - a. Table of contents, Section 8, Subdivision (b), at page 1 is modified to read: "Employment classes omitted from Section 7(b) or Section 8(a)."
