## OPINION

These are applications by Douglas Bus Lines, Inc. (Douglas), a Passenger Stage Corporation operating under Certificates of Public Convenience and Necessity (PSC-453) granted by this Commission. Douglas requests authority to extend its "home-to-work" commuter services in the Greater Los Angeles area.

The bulk of Douglas' present authority (Certificate Appendices A, B, C and D) was granted on a temporary basis by Decision 84274 in Case 9630, dated April 17, 1975, to expire July 1, 1975. The authority was placed on a temporary probationary status because of problems the carrier was experiencing with bus maintenance. This temporary authority was subsequently extended to August 15, 1975 (Decision 84620), and then to August 15, 1976 (Decision 84792). On August 14, 1976, this authority was further extended to August 15, 1977, with provision that, in the absence of a further Commission order to the contrary, these four certificates shall revert to regular permanent status effective August 15, 1977 (Decision 86242).

By Decision 85146, dated November 18, 1975, Douglas was granted an additional temporary certificate (Appendix "E") to operate



several new routes until August 15, 1976. By Decision 86268, dated August 14, 1976, Appendix E was extended on the same terms as were Appendices A, B, C and D above.

Pursuant to these several certificates, Douglas operates over 40 "home-to-work" passenger stage routes in Southern California and, as noted in Decision 86242, the California Highway Patrol has reported substantial improvement in this carrier's maintenance procedure and vehicle safety.

By Application 56726, Douglas requests authority to expand its "LAD service area". This will extend commute bus service to residents of an additional area generally encompassing Long Beach, Lakewood, Bellflower and Pico Rivera. Residents of the expanded service area will be provided "home-to-work" bus service to the Rockwell-International facility at 5701 West Imperial Highway, Inglewood, California. Service will be conducted in the same manner as applicant's present authorized operations. Applicant states it has available the necessary equipment, facilities, personnel and financial ability to render this new service.

By Application 56735, Douglas requests authority to operate three new services between certain Orange County communities and the Rockwell-International facilities in El Segundo; between Oxnard and the General Telephone Company in Santa Monica; and between five specified service areas and the Rockwell-International and McDonnell-Douglas facilities in Seal Beach. Applicant states it has available the necessary air-conditioned recliner coach equipment and other facilities to render these new services.

Copies of these applications were served on the Southern California Rapid Transit District. Application 56726 was also served on the City of Long Beach and the Long Beach Public Transportation Co. Application 56735 was also served on the Orange County Transit District, City of Seal Beach, City of Los Angeles Bureau of Public Utilities and Transportation and the City of Oxnard. Each application was listed in the Commission Calendar. The Long Beach Transportation

Company sent a conditional protest dated September 20, 1976, but, by letter dated December 22, 1976, it stated that it now has no objection. No other protests were received.

## FINDINGS

- Public convenience and necessity require that the requested authority be granted on a temporary basis until August 15, 1977. This authority should be subject to the same conditions as the applicant's present operating authority.
- 2. Applicant has the ability, experience and equipment to operate the requested service.
- 3. The proposed fares are reasonable.
- 4. A public hearing is not necessary.
- 5. It can be seen with certainty that there is no possibility that the project involved in this proceeding may have a significant effect on the environment.

## CONCLUSIONS

- 1. Applicant should be granted temporary authority to operate the service requested until August 15, 1977.
- 2. The authority granted herein should be subject to the conditions as set forth in the following order.
- 3. In the absence of a further order to the contrary, this authority should revert to a regular permanent status as of August 15, 1977.
- 4. Applicant is hereby placed on notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as the grant of such rights. Aside from their purely permissive aspect, such rights extend to the holder a full or partial monopoly of a class of business. This monopoly feature may be modified or canceled at any time by the State, which is not in any respect limited as to the number of rights which may be given.

5. Applicant's present certificate appendices should be revised to reflect the extensions of operating authority granted by Decisions 86242 and 86268, and also the new authority granted by this decision.

#### ORDER

IT IS ORDERED that:

Applicant is granted temporary authority to operate the services requested by Applications 56726 and 56735. Appendices A and B of Decision 72272, Appendices C and D of Decision 84274 and Appendix E of Decision 85146 are amended by incorporating the following original page and revised pages, attached hereto, in revision of the pages indicated thereon:

- 2. In providing service pursuant to the authority granted by this order, applicant shall comply with the following service regulations. Failure so to do may result in a cancellation of the authority.
  - (a) Within thirty days after the effective date of this order, applicant shall file a written acceptance of the authority granted. Applicant is placed on notice that if it accepts the authority it will be required, among other things, to comply with the safety rules administered by the California Highway Patrol, the rules and other regulations of the Commission's General Order No. 98-Series and the insurance requirements of the Commission's General Order No. 101-Series.

- (b) Within one hundred twenty days after the effective date of this order, applicant shall establish the authorized service and file tariffs and timetables, in triplicate, in the Commission's office.
- (c) The tariff and timetable filings shall be made effective not earlier than five days after the effective date of this order on not less than five days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the authorized service.
- (d) The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79-Series and 98-Series.
- (e) Applicant shall maintain its accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission on or before March 31 of each year, an annual report of its operations in such form, content and number of copies as the Commission, from time to time, shall prescribe.
- 3. The operating authority granted herein may be revoked or further modified in the event applicant fails to:
  - (a) Continue a preventive bus maintenance program satisfactory to the California Highway Patrol.
  - (b) Continue a satisfactory program for cleaning its buses.
  - (c) Report to the Commission in writing within twenty days after any vehicle inspection by the California Highway Patrol or Commission staff, advising of the improvement in vehicles and company practices found necessary in such inspection.

- (d) Report any mechanical failures or any out-offuel occurrences, which may happen in any of
  its operations, to the Commission staff by
  telephone within twenty-four hours of the
  failure or occurrence, which report shall be
  confirmed in writing within three working days.
- 4. This temporary authority shall revert to a permanent status effective August 15, 1977, in the absence of a further order to the contrary.

The effective date of this order shall be twenty days after the date hereof.

\*Douglas Bus Lines, Inc., is authorized to transport passengers between Douglas Aircraft Company, Inc., located at 3855 Lakewood Boulevard, Long Beach, on the one hand, and Areas 1, 2, or 3, on the other hand; and between the North American Autonetics plant located at 3330 Anaheim Road, Anaheim, on the one hand, and Areas 1, 2, 3, 4, 5 or 6, on the other hand; and between the North American Rockwell Aircraft Corporation main aircraft factory at 5701 West Imperial Highway, El Segundo, on the one hand, and Areas MV and LAD, on the other hand; and between the McDonnell-Douglas Aircraft Plant, 12214 S. Lakewood Boulevard, Downey, on the one hand, and Areas 1 and 2, on the other hand; and between the Conductron-Missouri Plant, 12254 Bellflower, Downey, on the one hand, and locations in Upland, Pomona and West Covina, on the other hand; between Areas A, B and C as hereinafter described, on the one hand, and the Autonetics Laguna Niguel Facility (24000 Avila Road), Laguna Niguel, on the other hand; and between Areas GT-1 and 2, on the one hand, and the General Telephone Company building in Santa Monica, on the other hand, over and along the routes hereinafter described and subject to the following conditions and restrictions:

#### AREA C
