OPINION AND ORDER

By this application, as amended, Keeney Truck Lines, Inc. requests authority to deviate from the provisions of Minimum Rate Tariff 15 in connection with the transportation of bakery products (other than frozen) for S. B. Thomas by adjusting the service hours concerning the computation of premium charges for Saturdays, Sundays, and holidays.¹

The application, as amended, is based on special circumstances and conditions detailed therein.

Revenue and expense data submitted by applicant indicate that the transportation involved may reasonably be expected to be profitable under the proposed rates.

The application and amendment were listed on the Commission's Daily Calendars of December 14, 1976 and February 14, 1977, respectively. California Trucking Association stated that the description "Bakery Products" is indefinite and includes frozen bakery goods. Applicant, by amendment filed February 10, 1977, has clarified the commodity description by excluding frozen bakery products.

¹ Applicant will assess the existing minimum rates, but adjust the computation of time for premium pay so that Saturday charges will apply from noon Tuesday to noon Wednesday, Sunday charges will apply from noon Saturday to noon Sunday and holiday charges will apply from noon of the day preceeding the holiday to noon of the holiday. Except for services performed in excess of 8 out of 9 consecutive hours, charges based on regular pay will be assessed for services performed at other time periods during the week.

In the circumstances, the Commission finds that applicant's proposal is reasonable. A public hearing is not necessary. The Commission concludes that the application, as amended, should be granted as set forth in the ensuing order and the effective date of this order should be the date hereof because there is an immediate need for this relief.

IT IS ORDERED that:

1. Keeney Truck Lines, Inc., a corporation, is authorized to perform the transportation shown in Appendix A attached hereto and by this reference made a part hereof at not less than the rates set forth therein.

2. The authority granted herein shall expire one year after the effective date of this order unless sooner cancelled, modified or extended by further order of the Commission.

The effective date of this order is the date hereof.

APPENDIX A

Carrier: Keeney Truck Lines, Inc.
Shipper: S. B. Thomas, Inc.
Territory: Radius of 250 miles from the base of operations designated in the written agreement.
Commodities: Bakery Products (other than frozen).
Rates: Monthly vehicle unit rates otherwise described in Minimum Rate Tariff 15 shall apply, except that rates include service on Saturday, Sunday and Holidays as set forth below:

1. Saturday charges shall apply from 12:01 p.m. Tuesday to Noon Wednesday.
2. Sunday charges shall apply from 12:01 p.m. Saturday to Noon Sunday.
3. Holidays, as defined in Minimum Rate Tariff 15, shall be deemed to run from 12:01 p.m. of the day preceeding the holiday to Noon of the holiday.
