SUPPLEMENTAL OPINION AND ORDER

By Decision 85109 in Application 55954, Peter Lawrence Heine, doing business as The Mendocino Stage, was granted a Certificate of Public Convenience and Necessity to operate as a passenger stage corporation between certain points in Mendocino County operating daily except on Sundays.

By this Petition for Modification, petitioner now seeks to operate daily, including Sundays. Petitioner alleges that his service was originally meant to be operated daily to accommodate tourists visiting, and residents living in the Fort Bragg-Mendocino area, but the certificate was inadvertently restricted to exclude Sundays.

The Petition for Modification was listed on the Commission's Daily Calendar on January 13, 1977. The Commission's Transportation Division staff has reviewed the Petition and recommends that in the absence of protest or request for public hearing it be granted by ex parte order.

No protest has been received.

After consideration, the Commission finds that the proposed modification would not be adverse to the public interest.

IT IS ORDERED that:

Appendix A of Decision 85109 is amended by incorporating First Revised Page 1, attached hereto, in revision of Original Page 1.

The effective date of this order shall be twenty days after the date hereof.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS
AND SPECIFICATIONS.

Peter Lawrence Heine, an individual doing business as The Mendocino Stage, by the Certificate of Public Convenience and Necessity granted by the decision noted in the margin is authorized as a Passenger Stage Corporation to transport passengers and their baggage between Fort Bragg and Little River Airport and points intermediate thereto, between Fort Bragg and Heritage House and between Little River and Heritage House; and to transport express shipments weighing less than fifty (50) pounds between Fort Bragg, on the one hand, and Mendocino, Little River, Little River Airport and Heritage House, on the other hand; over and along the route hereinafter described subject, however, to the authority of this Commission to change or modify said route at any time and subject to the following provisions:

- (a) When route descriptions are given in one direction, apply in either direction unless otherwise indicated.
- *(b) Service will be operated daily.
