Alco Transportation Co. (ATC) and Alco Fast Freight, Inc. (AFF), both California corporations and transferors herein, each hold a highway common carrier certificate from this Commission and a Certificate of Registration from the Interstate Commerce Commission based on their respective state certificates. Penguin Trucking Co., Inc. (PENGUIN), a California corporation and transferee herein, has entered into an agreement with transferors to purchase from them a portion of their intrastate and interstate operating authorities more fully described below.

The Interstate Commerce Commission, acting under its exclusive and plenary jurisdiction under Section 5 of the Interstate Commerce Act, has approved the entire transaction in Docket No. MC-F-12741 bearing a service date of December 23, 1976. In its order, the Interstate Commerce Commission directed PENGUIN, ATC and AFF to file with said Commission a certified copy of each of their supporting state certificates issued herein or, in lieu thereof, a certified copy of the California Commission's decision approving the partial transfers of the operating rights involved, together with a statement in writing confirming the date of consummation of the intrastate transaction.

In keeping with this requirement, the parties herein have filed this application. The existing state certificates, including amendments thereto, held by the transferors are identified as follows:

1. ALCO TRANSPORTATION CO. (ATC)

Decision 81377 dated May 15, 1973 in Application 53212. Certificate authorizes the transportation of general commodities generally between points within the Los Angeles Basin Territory, the San Diego Territory and all points located between said territories, and including San Ysidro, via certain specified routes.

2. ALCO FAST FREIGHT, INC. (AFF) (Previously known as Campora Fast Freight, Inc.) Decision 61587 dated February 28, 1961 in Application 42573, as amended. This certificate, originally granted to Speedy Transport, Incorporated, was extensively amended by: Decision 63663 dated May 8, 1962 in Application 42573; Decision 63664 dated May 8, 1962 in Application 44039; Decision 76758 dated February 10, 1970 in Application 42573; Decision 82136 dated November 13, 1973 in Application 42573; and Decision 83052 dated June 25, 1974 in Application 42573. AFF's current certificate authorizes the transportation of general commodities between points in the San Francisco Territory; Los Angeles Basin Territory; the Counties of Contra Costa, Sacramento, San Joaquin, Stanislaus and Merced; all points on or within 25 miles laterally of designated highways between: Sausalito and Petaluma; San Fernando and Redding; Hayward, also Sacramento and the California-Nevada State Line; as well as between various points in northern San Joaquin Valley; and between various points located on the north and west shores of Lake Tahoe.

PENGUIN, which now only holds permit carrier authority from this Commission, proposes to acquire from both ATC and AFF only that portion of their respective general commodity certificates which now includes the transportation of "Commodities requiring the use of special refrigeration or temperature control in specially designed and constructed refrigerator equipment" between all of the territories and points that ATC and AFF are

individually authorized to serve. If the proposed transfer is authorized, ATC and AFF would both retain, under restated certificates, all of their present operating authorities other than the transportation of articles moving under refrigeration sought to be transferred to PENGUIN.

Included with the application and identified as Exhibit "A" is a "Purchase and Sale Agreement" entered into by the parties involved herein on October 10, 1975. The agreement indicates that the purchase price which PENGUIN agrees to pay for both portions of transferors' operating authorities is \$16,000 which includes a down payment of \$3,500. Of the purchase price, \$4,500 is ATC's share and \$11,500 is to be paid to AFF. The purchase price covers those portions of ATC's and of AFF's operating authorities, both intrastate and interstate, without any allocation between the two types of regulatory authority. No other financial considerations are involved.

The application herein seeks this Commission's approval of the transfer of those portions of ATC's and AFF's California intrastate certificates which now include and authorize the transportation of temperature-controlled commodities in refrigerator equipment. PENGUIN requests that it be granted a certificate to cover these partial operating authorities; and ATC and AFF request that their respective certificates be restricted to exclude therefrom the transportation of commodities requiring refrigerator equipment between all of the points each of them is respectively authorized to serve.

A copy of the application was mailed to California Trucking Association at their request. Notice of the filing of the application appeared in the Commission's Daily Calendar of January 11, 1977. No protests to this application have been received.

In view of the fact that the Interstate Commerce Commission under its plenary jurisdiction and by its Order served December 23, 1976, has already approved the partial transfer of ATC's and AFF's interstate operating rights to PENGUIN, applicants request that this matter be handled by ex parte order and that the resultant decision be made effective on the date it is signed; also that the necessary tariff publications be authorized for publication on five (5) days' notice to the public.

After consideration, the Commission finds:

1. This application is a matter over which the Interstate Commerce Commission has plenary jurisdiction and has given its approval.

2. The proposed partial sale and transfer of the intrastate certificates will not be adverse to the California public interest.

3. The effective date of this order should be the date the order is signed and necessary tariff publications should be authorized for publication on five days' notice to the public.

The Commission concludes that the application should be granted as set forth in the ensuing order. A public hearing is not necessary. The order which follows will provide for, in the event the transfers are consummated: (a) the granting of a California certificate to PENGUIN limited to the specialized transportation of articles requiring movement in refrigerator equipment; (b) the granting of in-lieu California certificates to both ATC and AFF restricted to exclude the specific operating rights transferred to PENGUIN, respectively; and (c) the revocation of all California certificates, including amendments thereto, now held by ATC and AFF, respectively, as identified above. In each instance, the territorial descriptions and routes in these new certificates reflect the current identification of redesignated territorial boundaries, highways, roads or streets and do not in any way broaden or change the interstate or foreign commerce rights now held by the transferring carriers involved.

PENGUIN is placed on notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as the consideration for the grant of such rights. Aside from their purely permissive aspect, such rights extend to the holder a full or partial monopoly of a class of business. This monopoly feature may be modified or cancelled at any time by the State which is not, in any respect, limited as to the number of rights which may be given. The authorization granted shall not be construed as a finding of the value of the rights to be transferred.

O R D E R

IT IS ORDERED that:

1. On or before May 15, 1977, ALCO TRANSPORTATION CO. and ALCO FAST FREICHT, INC. may sell and transfer the portion of their respective operating rights referred to in this application to PENGUIN TRUCKING CO., INC.

2. Within thirty days after the transfer, PENGUIN TRUCKING CO., INC. shall file with the Commission a written acceptance of the certificate and a true copy of the bill of sale or other instrument of transfer.

3. Applicants shall amend or reissue the tariffs on file with the Commission, naming rates and rules governing the authority granted by this decision to show that they have adopted or established, as their own, the rates and rules. The tariff filings shall be made effective not earlier than five days after the effective date of this order on not less than five days notice to the Commission and the public, and the effective date of the tariff filings shall be concurrent with the transfer.

4. The tariff filings made pursuant to this order shall comply in all respects with the regulations governing the construction and filing of tariffs set forth in the Commission's General Order 80-Series. Failure to comply with the provisions of General Order 80-Series may result in a cancellation of the operating authorities granted by this decision.

5. In the event the transfers authorized in paragraph 1 are completed, effective concurrently with the effective date of the tariff filings required by paragraph 3, certificates of public convenience and necessity are granted to: (a) PENGUIN TRUCKING CO., INC. authorizing it to operate as a highway common carrier, as defined in Section 213 of the Public Utilities Code, for the transportaion of "Commodities requiring the use of special refrigeration or temperature control in specially designed and constructed refrigerator equipment"; (b) ALCO TRANSPORTATION CO., an in-lieu certificate for the transportation of "General Commodities, excluding those which are required to be transported in refrigerator equipment"; and (c) ALCO FAST FREIGHT, INC., an in-lieu certificate for the transportation of "General Commodities, excluding those which are required to be transported in refrigerator equipment"; between the territories, the points and over the routes as set forth in Appendices A, B and C, respectively, attached hereto and made a part hereof.

6. The certificates of public convenience and necessity granted or amended by Decisions 81377, 61587, 63663, 63664, 76758, 82136 and 83052 are hereby revoked effective concurrently with the effective date of the tariff filings required by paragraph 3.

7. PENGUIN TRUCKING CO., INC., ALCO TRANSPORTATION CO. and ALCO FAST FREIGHT, INC. shall comply with the safety rules administered by the California Highway Patrol and the insurance requirements of the Commiscion's General Order 100-Series.

8. PENCUIN TRUCKING CO., INC., ALCO TRANSPORTATION CO. and ALCO FAST FREIGHT, INC. shall maintain their accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before April 30 of each year, an annual report of their operations in such form, content and number of copies as the Commission, from time to time, shall prescribe.

PENGUIN TRUCKING CO., INC., ALCO TRANSPORTATION CO. and 9. ALCO FAST FREIGHT, INC. shall comply with the requirements of the Commission's General Order 84-Series for the transportation of collect on delivery shipments. If they elect not to transport collect on delivery shipments, they shall make the appropriate tariff filings as required by the General Order.

The effective date of this order shall be the date hereof.
