ORDER OF DISMISSAL AND REVOCATION  
OF DECISION NO. 86269

By Decision No. 86269 dated August 17, 1976, Ben Salamoni, dba Ben Salamoni Trucking Service, and Pacific Construction Trucking, Inc. were granted interim authority to deviate from the Commission's established minimum rates for transportation of fill material in dump truck equipment from Redwood City to Foster City for Piombo Construction Company.

By letter dated April 13, 1977, Ben Salamoni, dba Ben Salamoni Trucking Service, and Pacific Construction Trucking, Inc. request withdrawal of Application No. 56642 and 56645. They also request cancellation of the interim authority set forth in Decision No. 86269.

IT IS ORDERED that:

1. Application No. 56642 is dismissed.
2. Application No. 56645 is dismissed.
3. The authority granted by Decision No. 86269 dated August 17, 1976 in the instant applications is revoked.

The effective date of this order shall be twenty days after the date hereof.
