ORDER GRANTING PARTIAL STAY

Petitions for rehearing or reconsideration of the Order Instituting Investigation in this proceeding have been filed by a number of respondents. In addition, a number of respondents have filed, either as part of such petitions or separately, petitions for a stay of that portion of the order requiring the respondents to present a comprehensive report concerning the hiring and promotion of minority employees, as designated by relevant state and federal regulations, within sixty days of the effective date of the order.

We believe it is appropriate to grant a stay of that portion of the Order requiring reports in sixty days. We are not, however, by this action indicating any decision as to the merits of any issue raised by the petitioners in their filings.

IT IS HEREBY ORDERED that the portion of the Order Instituting Investigation, dated April 12, 1977, in this proceeding which orders as follows:

"IT IS FURTHER ORDERED that each respondent utility shall, within sixty days of the effective date of this order, present a comprehensive report concerning the hiring and promotion of minority employees as designated by relevant state and federal regulations, including copies of all correspondence between Fair Employment Practices Commission and the Equal Employment Opportunity Agency in the past two years."
