SUPPLEMENTAL OPINION AND ORDER

By Decision 87357 dated May 17, 1977, Russell Truck Company was granted authority to deviate from the provisions of Minimum Rate Tariff 2 in connection with the transportation of aluminum cans for Continental Can Company from San Mateo to various points in California.

Russell Truck Company has informed this Commission by letter that it inadvertently referred to San Mateo as the point of origin in its application when Commerce, Van Nuys, Los Angeles and San Pedro should have been indicated as the points of origin.

In the circumstances, the Commission finds that the necessary corrections should be made by the order herein. A public hearing is not necessary. The Commission concludes that Decision 87357 should be amended accordingly and the effective date of this order should be the date hereof because there is compelling need to rectify this matter.

IT IS ORDERED that Decision 87357 is hereby amended by substituting for Appendix A thereof Amended Appendix A which is attached hereto and by this reference made a part hereof.

AMENDED APPENDIX A

CARRIER: Russell Truck Company  
SHIPPER: Continental Can Company  
COMMODITY: Aluminum Cans  
FROM: Commerce, Los Angeles, San Pedro and Van Nuys  
TO: Various points in California  
MINIMUM WEIGHT: 20,000 pounds  
RATES: Commodity rates named in Item 640 of Minimum Rate  
Tariff 2

Conditions:

1. Freight charges shall be prepaid by Continental Can Company.
2. Shipments shall be power loaded by the shipper and power unloaded by the consignee without assistance of, or expense to, the carrier.
3. One load of pallets shall be returned for every seven loads of cans shipped to each consignee.
4. The authority granted herein does not apply to shipments transported by any carrier other than applicant.
5. In all other respects, the rates and rules in Minimum Rate Tariff 2 shall apply.
