ORDER OF REVOCATION AND ORDER RESCINDING DECISION

By Decision 86655, dated November 23, 1976 in Application 56624 Patrick D. Linington, doing business as Carmel Motoring Company, was authorized to transfer his Certificate of Public Convenience and Necessity to operate as a passenger stage corporation to Carmel Motoring Company, a corporation, on or before April 1, 1977. The transferee was required to file with the Commission written acceptance of the certificate, an instrument of transfer, a Certificate of Insurance in compliance with General Order 101-C, and tariff and timetable. None of these documents were filed with this Commission.

On April 11, 1977 the Commission received a letter from Counsel George D. Ford, dated April 8, 1977 that stated: "I have been advised by the operators of Carmel Motoring Company that they have ceased operations, and wish to abandon their certificate and permit to operate as a charter carrier".

It appears and the Commission finds that there is good cause for rescinding Decision 86655 and revoking the Certificate of Public Convenience and Necessity issued by Decision 85578 and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that Decision 86655 should be rescinded and Decision 85578 should be revoked and that tariffs and timetables applicable to the service thereunder should be canceled.

IT IS ORDERED that Decision 86655 in Application 56624 is rescinded and that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation authorized by Decision 85578, dated March 16, 1976, in Application 56243, is hereby revoked and all effective tariffs and timetables on file with the Commission in the name of Patrick D. Linington, doing business as Carmel Motoring Company, are canceled upon the effective date of this order.
