SUPPLEMENTAL ORDER EXTENDING TIME

The Commission in Decision No. 87253 dated April 26, 1977 in Case No. 10207 ordered, among other things, the following:

"2. Hal Simmons Trucking Co. shall pay a fine to this Commission pursuant to Public Utilities Code Section 3800 of \$14,046.08 on or before the fortieth day after the effective date of this order."

* * *

"6. Hal Simmons Trucking Co., excepting those shipments already identified in Parts 1 through 8 of Exhibit 4 shall (a) review its business records, including all freight bills, mill tags, bookkeeping and/or other supporting documents relating to the transportation of property without charge for Coastal and Georgia-Pacific,

during the period from September 1, 1974, to November 16, 1976, (b) file its report with the Commission by June 1, 1977 which report shall include the identity of all shipments hauled without charge and show the minimum rate and charge applicable to each such shipment which charges are to be billed to Coastal and Georgia-Pacific by June 15, 1977, and (c) in the event any such undercharge remains uncollected by August 1, 1977, legal remedies shall be timely utilized to effect collection, and a report covering the collection status of such undercharges shall be filed with the Commission on September 5, 1977 and the first Monday of each month thereafter until such undercharges have been collected in full or until further order of the Commission."

On June 7, 1977 the attorneys for Hal Simmons Trucking Co. requested a 30-day extension of the times set forth in the two ordering paragraphs above. The staff has reviewed the request and has no objection to the extension.

Therefore, IT IS ORDERED that the time within which Hal Simmons Trucking Co. shall comply with Ordering Paragraphs 2 and 6 of Decision No. 87253 is extended thirty days from each of the dates specified in those ordering paragraphs.

In all other respects Decision No. 87253 shall remain
in full force and effect.
