INTERIA OPINION AND ORDER

By this application, Dalton Trucking, Inc. requests authority to deviate from the provisions of Minimum Rate Tariff 7-A in connection with transportation of slag for Heckett Engineering Co. from Kaiser to Murrieta Hot Springs and points within five miles of said community.

The application is based on special circumstances and conditions detailed therein.

The application was listed on the Commission's Daily Calendar of May 18, 1977. California Trucking Association (CTA) objected to the ex parte handling of this matter stating that the reasonableness of the proposed rates cannot be measured from the data submitted by applicant. CTA avers that, although applicant indicates it intends to engage subhaulers, no costs have been developed for the use of subhaulers.

California Dump Truck Owners Association declares that it does not oppose the granting of the requested deviation on the assumption that the Commission will issue its usual order limiting the reduced rate to applicant's own units of equipment.

However, it requests nearing in this matter if applicant desires that the sought rates be made applicable to subhaulers.

Revenue and expense data submitted by applicant are sufficient to determine that the transportation involved may reasonably be expected to be profitable under the proposed rates.

In the circumstances, the Commission finds that:

- l. Applicant's proposal is reasonable for transportation performed by it.
- 2. Applicant's proposal is reasonable on a temporary basis pending hearing for transportation performed by the involved subhaulers.
- 3. Any undue delay in this matter would not be in the public interest inasmuch as the proposed rate would enable the shipper to make use of a waste product.
- 4. Applicant shall direct the underlying carriers involved to measure their cost data for the aforementioned transportation during the interim period of this authority for presentation at a public hearing to be scheduled.

The Commission concludes that the application should be granted as set forth in the ensuring order and the effective date of this order should be the date hereof because there is an immediate need for this rate relief.

IT IS ORDERED that:

- 1. Dalton Trucking, Inc. is authorized to perform the transportation shown in Appendix A attached hereto and by this reference made a part hereof at not less than the rates set forth therein.
- 2. The authority granted herein shall expire one year after the effective date of this order unless sooner cancelled, modified or extended by further order of the Commission.

- 3. Dalton Trucking, Inc. shall provide the Commission and all parties to this proceeding with the data specified in Finding 4 hereof.
- 4. A public hearing shall be scheduled on this application at a date to be set in connection with transportation performed by the involved subhaulers under the rate authorized herein.

The effective date of this order is the date hereof.

- 3. Shipper shall issue all shipping documents, including the applicable transportation rate.
- 4. In the event subhaulers are used, they shall receive not less than 95% of the authorized rate.
- 5. In all other respects, the rates and rules in Minimum Rate Tariff 7-A shall apply.
